### AGENDA HEADING:

Approve expansion of the Brook Run Neighborhood boundaries in accordance with the Neighborhood Recognition Policy.

### SYNOPSIS:

The Brook Run Neighborhood Association requests approval of a proposed boundary expansion of the Brook Run Neighborhood to include East Douglas Avenue to the north, Brook Landing Court to the south, East 56<sup>th</sup> Street to the east, and East 53<sup>rd</sup> Court to the west.

### ADDITIONAL INFORMATION:

- Boundaries for proposed expansion includes NE 38<sup>th</sup> Avenue/East Douglas Avenue between East 49<sup>th</sup> Street and East 56<sup>th</sup> Street to the north, Stream Side Circle between East 49<sup>th</sup> Street and East 53<sup>rd</sup> Court and Brook Landing Court between East 53<sup>rd</sup> Court and East 56<sup>th</sup> Street to the south, East 56<sup>th</sup> Street between East Douglas Avenue and Brook Landing Court to the east, and East 49<sup>th</sup> Street between NE 38<sup>th</sup> Avenue/East Douglas Avenue and Stream Side Circle to the west.
- Existing boundary area:
  - North: NE 38<sup>th</sup> Avenue/East Douglas Avenue
  - South: Stream Side Circle
  - East: East 53<sup>rd</sup> Court
  - West: East 49<sup>th</sup> Street
- Proposed boundary expansion to include:
  - North: East Douglas Avenue
  - South: Brook Landing Court
  - East: East 56<sup>th</sup> Street
  - West: East 53<sup>rd</sup> Court



- The proposed area is currently not part of a recognized neighborhood.
