AGENDA HEADING:

Approving Professional Services Agreement (PSA) with Ace Pipe Cleaning, Inc. for professional services for 2022 Sanitary and Storm Sewer Televising Inspection and Analysis Program, for an amount not to exceed \$556,300.

SYNOPSIS:

Approving the PSA with Ace Pipe Cleaning, Inc. (Theresa Calvert, Vice President, 6601 Universal Avenue, Kansas City, Missouri, 64120-1330), for a total cost not to exceed \$556,300, based on unit costs of items completed, as indicated in the Consultant's Standard Fee Schedule, to provide storm and sanitary sewer inspections and analyses in compliance with the National Association of Sewer Service Companies' (NASSCO) Pipe Assessment and Certification Program (PACP) for the 2022 Sanitary and Storm Sewer Televising Inspection and Analysis Program.

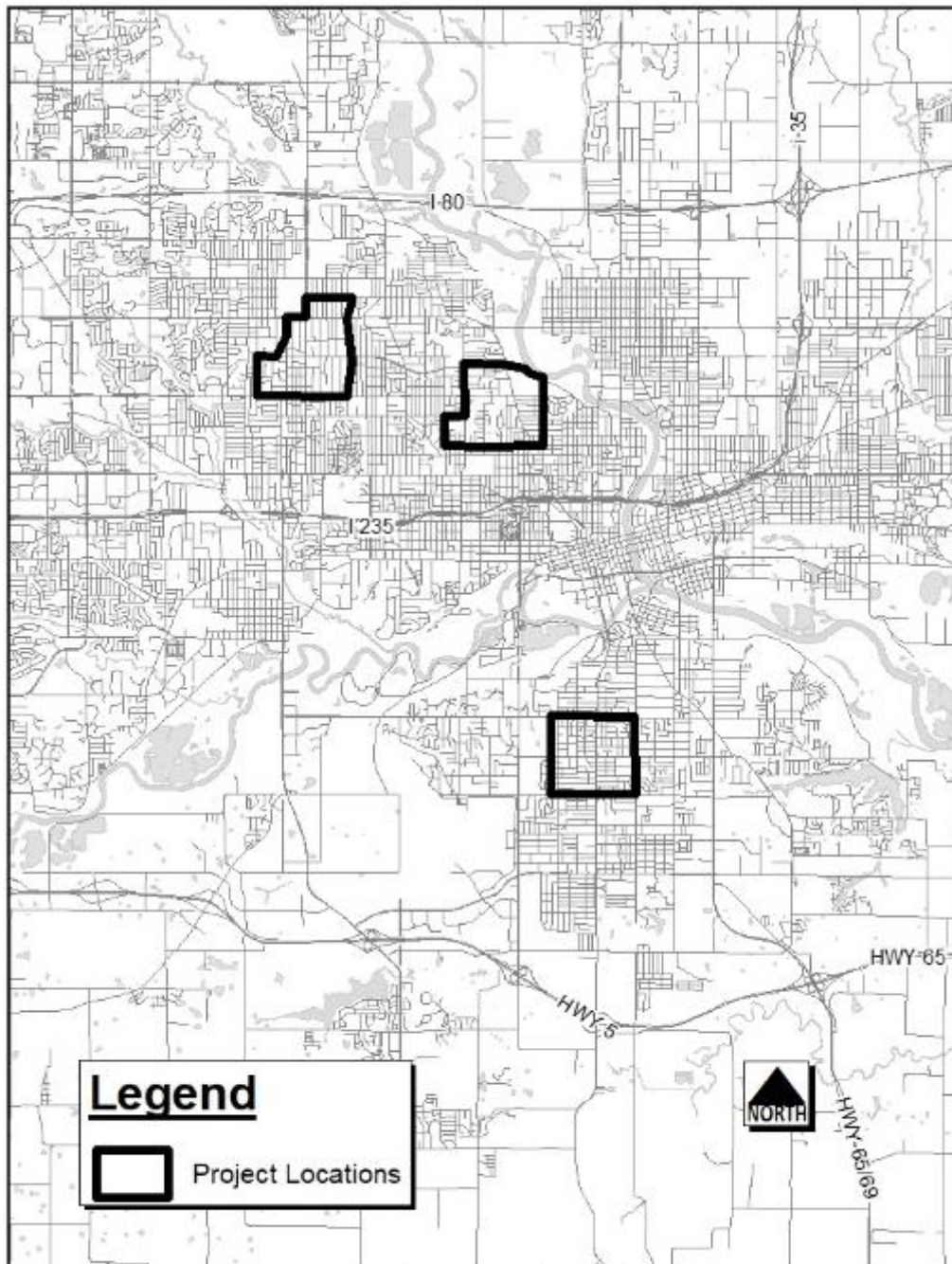

ADDITIONAL INFORMATION:

- This project provides for the inspection of sanitary and storm sewers throughout the City of Des Moines and includes video inspection, manhole inspection, and manhole location of the sanitary and storm sewer systems. This project is the start of a comprehensive program to examine the entire sewer systems to determine preventive maintenance and future CIP projects. This project focuses on three (3) localized areas which account for approximately 10% of the entire sanitary sewer system.
- A Request for Proposals (RFP) for storm and sanitary sewer video inspection and analysis services was issued and posted on the City's website. Four (4) proposals were received in response to the RFP. The selection committee was comprised of representatives from the Public Works and Engineering Departments. Ace Pipe Cleaning, Inc. was selected based on their qualifications, thorough understanding of the project requirements, and experience with similar projects.

- City staff negotiated a PSA with Ace Pipe Cleaning, Inc. for a total cost not to exceed \$556,300, based on unit costs for items completed in accordance with the Consultant's Standard Fee Schedule, to provide storm and sanitary sewer inspections and analyses in compliance with the National Association of Sewer Service Companies' (NASSCO) Pipe Assessment and Certification Program (PACP) and also perform basic sewer structure inspections in accordance with the City's process.
- This PSA will provide for TV inspection and analysis of three (3) areas of the City, as indicated in the location map below.
- Work on the project shall begin after issuance of the notice to proceed, and completion of the entire project is expected by December 31, 2022.
