AGENDA HEADING:

Acceptance of proposal from MidAmerican Energy Company to install new LED streetlights for 6th Avenue Streetscape – College Avenue to University Avenue, estimated at \$148,958.96.

SYNOPSIS:

Recommend acceptance of proposal from MidAmerican Energy Company, 200 SE 3rd Street, Des Moines, Iowa, 50309, to install new LED streetlights for 6th Avenue Streetscape – College Avenue to University Avenue.

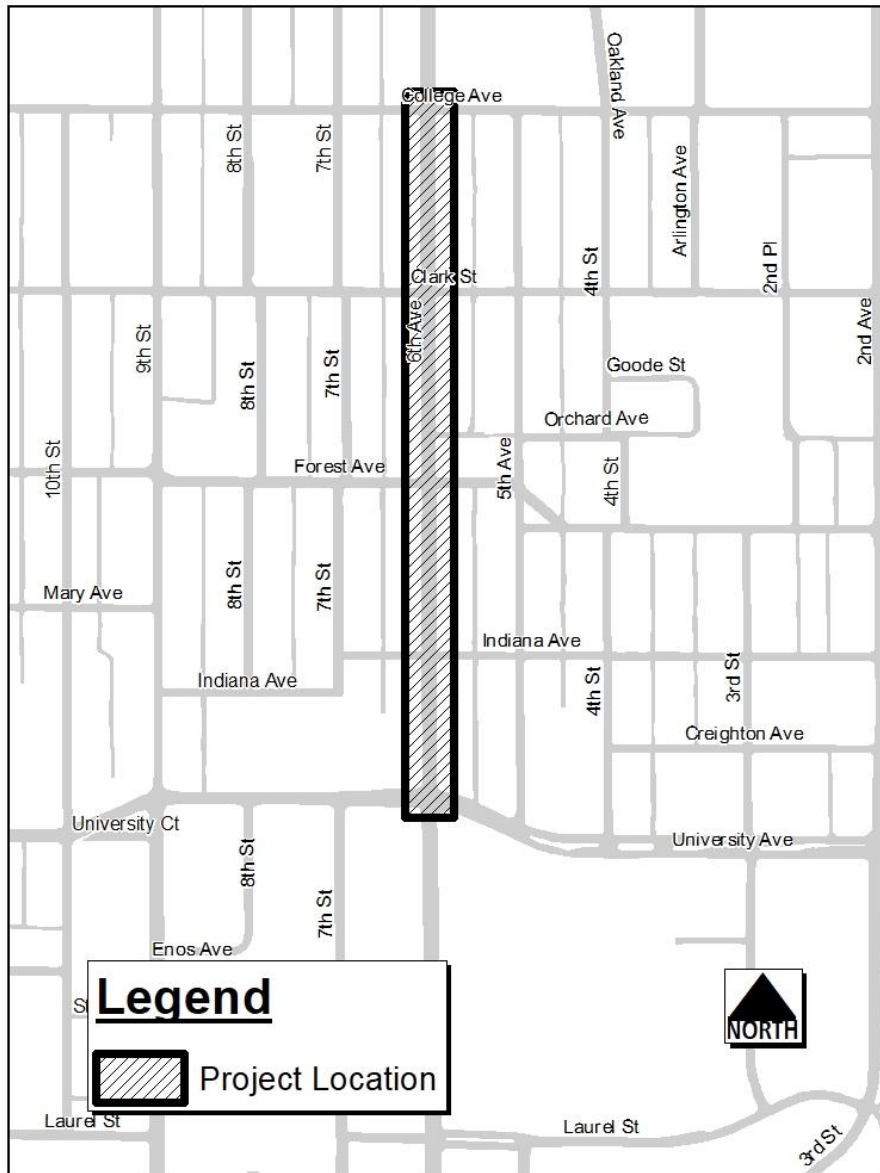
FISCAL IMPACT:

Amount: \$148,958.96

Funding Source: 2022-2023 CIP, Page 124, Sixth Avenue Streetscape, ST266, Being: Des Moines Water Works, Federal Funds, G.O. Bonds, and Private Funds.

ADDITIONAL INFORMATION:

- The 6th Avenue Streetscape – College Avenue to University Avenue project includes streetscape enhancements, roadway reconfiguration from five (5) travel lanes to three (3) travel lanes, improvements to pedestrian and bicycle facilities along the corridor, street tree planting, and constructing green infrastructure components such as biocells and permeable pavers.
- The project also includes new street lighting. MidAmerican Energy prepared plans to install 13 poles with LED light fixtures along the project. The LED light fixtures will all be on black, banner-strength, steel poles along 6th Avenue and served by underground conductors and are to be billed to the City at the wood pole overhead rate.
