AGENDA HEADING:

Approval of the purchase of maintenance and support for Hewlett-Packard (HP) 3PAR 8400 storage arrays from OneNeck IT Solutions per NASPO Contract MNNVP-134, State of Iowa Participating Addendum 16054C, which is competitively bid, and City of Des Moines Short Form No. K23-071.

SYNOPSIS:

Recommend approval of the purchase of maintenance and support for HP 3PAR 8400 storage arrays from OneNeck IT Solutions (Terry Swanson, President and CEO, 11191 Aurora Avenue, Urbandale, IA 50323) per State of Iowa Contract 16054, which is competitively bid. While video footage has moved to a cloud-based solution, verification of data migration is still needed. This purchase will keep these storage arrays under support with HP for security and maintenance issues.

ADDITIONAL INFORMATION:

- The City's Police Department is in the process of completing the replication and migration of its on-premise Body Camera footage to the Cloud. This storage will be needed until the project has been completed.
- The storage units are critical to the City's Police Department body camera operations and contain data and files for body camera footage and other types of digital evidence for ongoing investigations.
- The maintenance agreement provides coverage for hardware and software support of an essential part of the City's Police Department body camera data storage.
