AGENDA HEADING:

Recommend approval of purchase of Microsoft Azure Blob Storage from Insight Public Sector per Omnia Contract No. 4400006644, which is competitively bid, and City of Des Moines Short Form Contract No. K22-402.

SYNOPSIS:

Recommend approval of purchase of Microsoft Azure Blob Storage from Insight Public Sector (910 W. Carver Road, Tempe, AZ 85284, Joyce Mullen, President and CEO) per Omnia Contract No. 4400006644, which is competitively bid and City Contract No. K22-402, to be incorporated under the current Microsoft Enterprise Enrollment Agreement. This will approve the purchase of Azure Blob Storage for the duration of the agreement, ending April 30, 2025.

FISCAL IMPACT:

Amount: Not to exceed annual amount of \$60,000 for Azure Blob Storage.

ADDITIONAL INFORMATION:

- This purchase is part of the Information Technology Department's ongoing efforts to accommodate backup storage growth, improve backup and recovery performance, enhance security of the backup infrastructure, and storage of long-term backups with a cloud storage provider.
- The City's backup infrastructure is critical to fulfilling the City's disaster recovery and business continuity needs to protect the City's ongoing operations.
- Azure Blob Storage provides a cloud storage location for the City to replicate its data backups in the "Cloud" for offsite storage.
