## AGENDA HEADING:

Hearing on S.E. 6th Street Reconstruction from E. Hillside Avenue to E. Edison Avenue: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Brothers Cleaning Corporation, Josecito Valero, President, \$389,710.

## SYNOPSIS:

This is a public hearing to allow for public input on the S.E. 6th Street Reconstruction from E. Hillside Avenue to E. Edison Avenue and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the reconstruction of deteriorated pavement on S.E. 6th Street from E. Hillside Avenue to E. Edison Avenue.

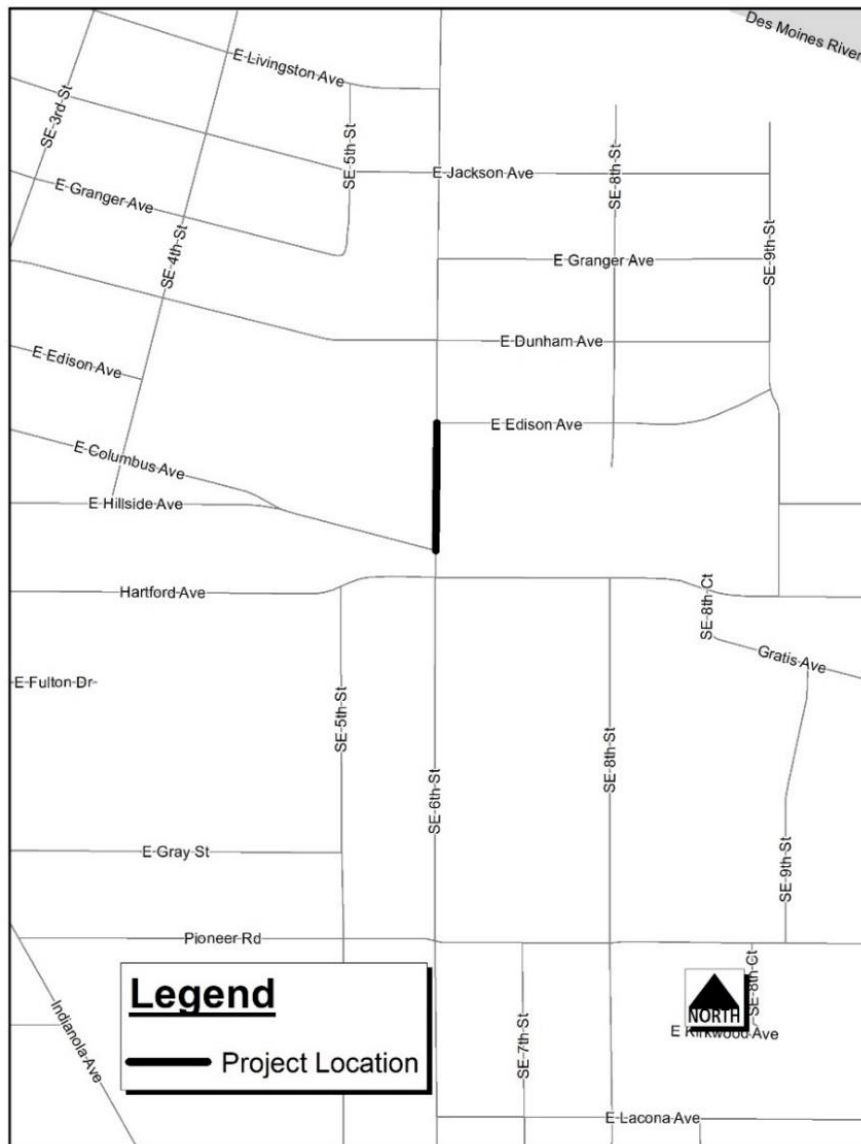
Amount: \$389,710 construction contract (\$400,000 City Engineer's Estimate).

## ADDITIONAL INFORMATION:

- On October 24, 2022, under Roll Call No. 22-1605, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the S.E. 6th Street Reconstruction from E. Hillside Avenue to E. Edison Avenue. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the S.E. 6th Street Reconstruction from E. Hillside Avenue to E. Edison Avenue, Activity ID 06-2022-009. The improvement includes construction of Portland Cement Concrete (PCC) pavement and integral curb, PCC driveways, PCC sidewalks, modified subbase, subdrain, pavement markings, traffic control, surface restoration, and incidental items; all in accordance with the contract documents, including Plan File No. 645-120/143, located on S.E. 6th Street from E. Hillside Avenue to E. Edison Avenue.

- The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on November 8, 2022.
  - The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Brothers Cleaning Corporation (Josecito Valero, President, 4000 Colfax, Des Moines, IA, 50317), in the amount of \$389,710, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
