AGENDA HEADING:

Items related to OpenLoop Health, Inc.:

- (A) Resolution approving final Iowa Economic Development Authority (IEDA) contract under the High-Quality Jobs (HQJ) Program for OpenLoop Health, Inc.
- (B) Resolution approving forgivable loan agreement between the City and OpenLoop Health, Inc.

SYNOPSIS:

OpenLoop Health, Inc. (317 6th Avenue, Suite 400, Des Moines, IA 50309, Jon Lensing, CEO) has secured financial assistance under the IEDA's HQJ Program. This rapidly growing company creates staffing, software solutions, technology platforms, and related support for the telehealth medical industry, and the company plans to renovate and modernize multiple floors within the existing office building at 317 6th Avenue for their use.

The \$18.9 million expansion includes expenses for building tenant improvements, furnishings, fixture, and equipment, product research and development costs, and overall base rent. The project will create 400 new jobs, 60 of which are anticipated to meet or exceed the state's HQJ wage threshold for Polk County of \$34.25 per hour, or \$71,240 annually.

The HQJ Program application for this project was awarded \$500,000 in direct financial assistance at their January 20, 2023, IEDA board meeting. The City is required to provide a local community financial match, which is being provided through a forgivable loan agreement utilizing the City's Economic Enterprise Account that will be reimbursed with funding from the Metro Center tax increment finance (TIF) District.

FISCAL IMPACT:

<u>Amount</u>: \$250,000

<u>Funding Source</u>: \$250,000 advanced from the Economic Development Enterprise Account, to be reimbursed by Metro Center TIF on or after July 1, 2024.

ADDITIONAL INFORMATION:

- OpenLoop Health, Inc. is a staffing, software and technology company that services the telehealth industry and is experiencing rapid business growth, with clientele in all 50 states. The company intends to expand their Des Moines-based operations starting in the first quarter of 2023.
- OpenLoop Health, Inc. has recently met with staff from both the City of Des Moines Office of Economic Development and the Greater Des Moines Partnership to discuss their proposed expansion plans within downtown Des Moines, including the lease of space and related updates and improvements to the existing 14-story office tower that they are located within.
- The company intends to seek assistance through the State of Iowa's HQJ direct financial assistance program, where a local match is necessary. Staff is proposing a \$250,000 forgivable loan to be advanced to meet the local match requirements, initially paid from the City's Economic Development Enterprise Account and reimbursed from the Metro Center TIF District after the start of the next fiscal year (FY).
- The proposed \$18.9 million expansion would yield a total of 400 new jobs over a span of three (3) years added to the existing 48 employees already working for the company in Des Moines. Of the proposed new jobs, 60 will meet or exceed the HQJ wage threshold of at least \$34.25 per hour, or \$71,240 annually.
- At full expansion, OpenLoop Health, Inc. would lease 40,000 square feet of space located at 317 6th Avenue and would invest at least \$2.5 million in tenant improvements into the building. This will greatly help in stabilizing an office building that is currently experiencing higher vacancy rates and is anticipated to increase the assessed value of the building as the building's occupancy stabilizes.
- The company anticipates generating at least 1,500 downtown hotel stays annually upon completion of the expansion, with an estimated \$400,000 annual economic impact.
- For compliance on the proposed forgivable loan agreement, there will be equivalent percentage reductions in loan forgiveness applicable at the end of a 3-year reporting cycle in the event that total job counts, average salaries, and total tenant improvement investments do not meet the anticipated levels as negotiated. If at the end of the 3-year reporting cycle, total jobs, wages and tenant improvement amounts meet or exceed the minimum thresholds in the agreement, the loan would be entirely forgiven.
