AGENDA HEADING:

The Police Department requests approval for a monetary increase to the previously approved contract with Galls LLC (1340 Russell Cave Rd. Lexington, KY 40505, Michael Wessner, CEO) for the purchase of uniforms and alteration services. The Procurement Administrator has determined this purchase has been competitively bid per State of Iowa contracts number 21283, 22035, 22023 and 22158.

SYNOPSIS:

The City Council approved a contract with Galls, LLC for the purchase of uniforms and alteration services during the November 7, 2022, Council meeting (Roll Call No. 22-1739) for \$125,000. The Police Department will exceed this spending limit by \$46,000 due to purchases accrued from the previous budget year that were not included in the original contract and an additional academy class held within the budget year. This request would increase the contracted amount to \$171,000.

ADDITIONAL INFORMATION:

The City entered into a contract with Galls, LLC. in November 2022 for the purchase of police uniforms and alteration services. The estimated amount to be spent under this contract was \$125,000. However, the carryover expense from last budget year and an additional academy class held this budget year will cause the department to exceed the originally approved spending limit. Additionally, there are two (2) months left in the FY2023 budget year which will have an impact on the amount of the contract as well. The Police Department anticipates the additional expenses to be \$46,000.
