## AGENDA HEADING:

Ordering construction of the following: 2024 Traffic Signal Replacement Contract 1 - Receiving bids, (11-7-23), and Setting date of hearing, (11-20-23). (Construction Estimate - \$475,000).

## SYNOPSIS:

Recommend the City Council order construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below.

The 2024 Traffic Signal Replacement Contract 1 public improvement project includes:

- Replacing the traffic signals at 6th Avenue and Center Street.
- Replacing the pedestrian signals at SE 6th Street near Granger Avenue.
- Replacing banner arms on existing poles in the Court Avenue District and the Western Gateway District.

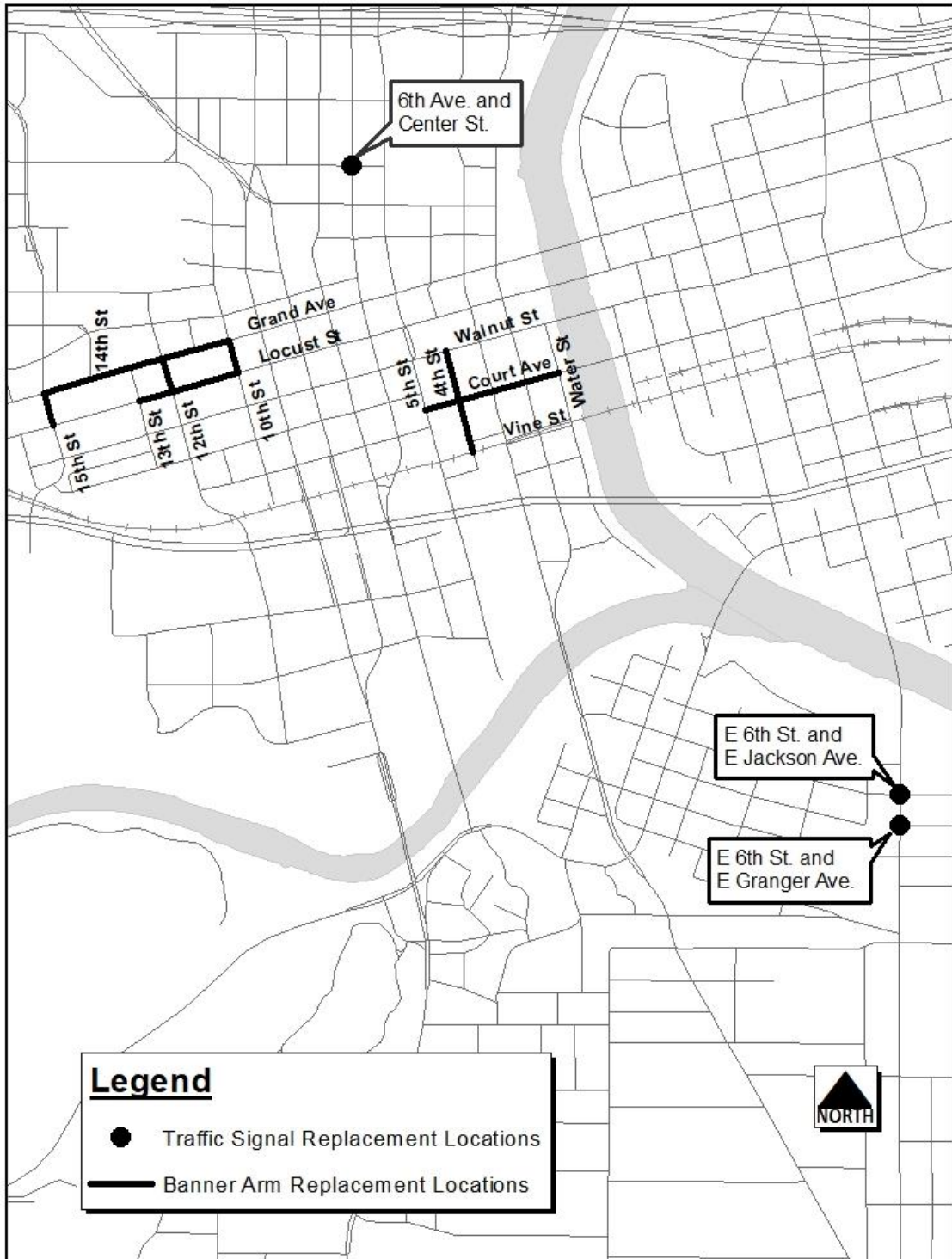
Amount: \$475,000 City Engineer's Estimate

Funding Source: 2023-2024 Capital Improvement Program (CIP), Page 177, Traffic Signals – Replacement, TR091, Being: \$250,000 in G.O. bonds, \$125,000 in G.O. bonds transferred from ST287, and the remaining \$100,000 in G.O. bonds transferred from ST300

## ADDITIONAL INFORMATION:

- The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2024 Traffic Signal Replacement Contract 1, Activity ID 042022022. The improvement includes the replacement of the traffic signals at two (2) locations, replacement of banner arms in two (2) locations, construction of Portland Cement Concrete (PCC) curb and gutter, PCC sidewalk, traffic signals, traffic signs, pavement markings, and other incidental items, all in accordance with the contract documents, including Plan File No. 657-165/191, located at 6th Avenue and Center Street, SE 6th Street near East Granger Avenue, Court Avenue District, Western Gateway District, and other locations directed by the Engineer.
- The estimated construction cost is \$475,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.

- Construction of this project is anticipated to be completed by fall of 2024.
