AGENDA HEADING:

Receive and file the Public Works Stormwater Infrastructure Advisory Committee (SIAC) 2022 Annual Report regarding the status of community goals and receive comments from the Committee Chair.

SYNOPSIS:

As part of the Public Works SIAC policies and rules, the Committee shall provide an annual report to the City Council on the status of the Committee goals. The Committee has drafted and finalized the report for submission to the City Council. The submission of the report was delayed in order to be filed in conjunction with the City Council work session regarding the City-Wide Stormwater Master Planning Program. The SIAC Committee Chair wanted to provide comments on the efforts of the Committee in 2022.

ADDITIONAL INFORMATION:

- The SIAC met five (5) times during 2022. They held in-person meetings in February, May, August, and November with a virtual option for those Committee members and the public who could not attend in person. They also held a supplemental meeting in October in order to provide feedback to the consultant on the City-Wide Stormwater Master Plan.
- The Committee membership remained relatively stable with seven (7) active members in 2022. Recruitment for new members has been ongoing.
- The Committee continued the work started in 2020, providing feedback to City staff on stormwater project prioritization, on capital budget process, and on proposed stormwater ordinance/policy updates. The major focus for 2022 was related to the development of the City-Wide Stormwater Master Plan.
