AGENDA HEADING:

Approving Supplemental Agreement No. 1 to the Professional Services Agreement (PSA) with Bolton & Menk, Inc. for additional work on Stone Park Sprayground Design, not to exceed \$219,500.

SYNOPSIS:

Recommend approval of Supplemental Agreement No. 1 to the PSA with Bolton & Menk, Inc. (Bradley C. DeWolf, P.E., President/CEO, 1960 Premier Drive, Mankato, Minnesota 56001-5900) for an amount not to exceed \$219,500, based on hourly labor rates and reimbursable costs, for additional design services and construction phase services for the Stone Park Sprayground Design Project.


ADDITIONAL INFORMATION:

- The Stone Park Sprayground project provides for the construction of a new sprayground, four (4) dedicated pickleball courts, court surface for a donated Kick It Forward mini-pitch futsal system, sidewalks, basketball court rehabilitation, segmental block wall, playground equipment, open-air shelter, site furnishings and associated improvements in Stone Park to provide replacement play opportunities and to better serve the neighborhood.
- On April 24, 2023, by Roll Call No. 23-0568, the City Council approved the PSA with Bolton & Menk, Inc. for a total cost not to exceed \$152,000, based on hourly rates, to provide design services for Stone Park Sprayground Design.
- On December 4, 2023, under Roll Call No. 23-1681, the City Council ordered construction of Stone Park Improvements.
- Bids for construction of the project were received on January 9, 2024.

- Construction on the Stone Park Improvements is anticipated to begin in spring 2024 and be completed in spring 2025.
- Workload capacity issues are preventing the City inspection staff from providing inspection services for all planned projects this coming construction season and, as a result, it was determined that this would be a good project to contract out for inspection services.
- Staff has negotiated Supplemental Agreement No. 1 to the PSA with Bolton & Menk, Inc. for a total additional amount not to exceed \$219,500 based on hourly labor rates and reimbursable costs for additional design services directed by the City, and for construction administration and inspection services.
