AGENDA HEADING:

Acceptance of a proposal from MidAmerican Energy Company to install streetlights on Broadway Avenue from 2nd Avenue to Hubbell Avenue, estimated at \$295,551.61.

SYNOPSIS:

Recommend acceptance of a proposal from MidAmerican Energy Company (200 SE 3rd Street, Des Moines, Iowa 50309) to install 50 streetlights within the City of Des Moines limits on Broadway Avenue from 2nd Avenue to Hubbell Avenue.

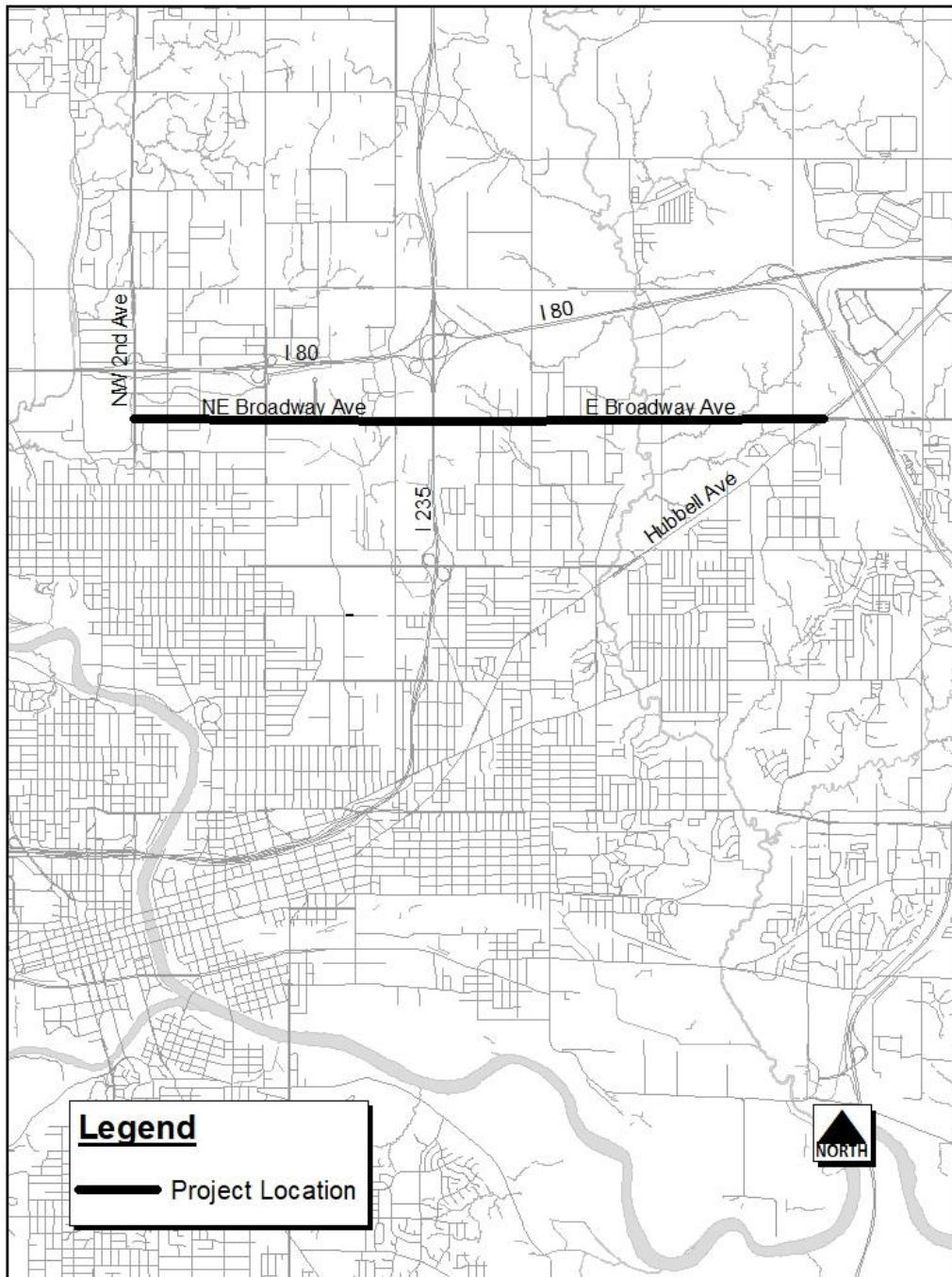
Amount: \$295,551.61

Funding Source: Fiscal Year (FY) 2023-2024 Capital Improvement Program (CIP), Page 155, Better Utilizing Investments to Leverage Development (BUILD) Grant – Broadway from 2nd Avenue to Hubbell, ST307, G.O. Bonds, Local Option Sales and Service Tax (LOSST)

ADDITIONAL INFORMATION:

- Polk County successfully applied for and received a \$25 million BUILD Grant for the reconstruction of Broadway from 2nd Avenue to Hubbell Avenue. Polk County is leading the project development and will administer the construction. City of Des Moines (City) staff are participating in design discussions and coordinating work within the City limits, including a portion near E. 14th Street and between E. 38th Street and Hubbell Avenue.
- On September 12, 2022, by Roll Call No. 22-1382, City Council approved the execution of an agreement for Cooperative Public Service with Polk County for the NE Broadway Avenue Improvement Project from Iowa Highway 415 (NW 2nd Avenue) to US Highway 6 (Hubbell Avenue).
- This proposal provides for MidAmerican Energy Company to:
 - Install 46 LED streetlights on steel, direct embed poles
 - Install 4 LED streetlights on wood poles

- The estimate from MidAmerican Energy for the work is \$295,551.61 and is budgeted as part of the Broadway from 2nd Avenue to Hubbell project costs. MidAmerican costs of \$295,551.61 on this agreement are for the work within the City limits.
