#### **AGENDA HEADING:**

Hearing on SW 9th Street Rehabilitation from Emma Avenue to Leach Avenue: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as TK Concrete, Inc., Tony J. Ver Meer, President, \$575,841.

### **SYNOPSIS:**

This is a public hearing to allow for public input on the SW 9th Street Rehabilitation from Emma Avenue to Leach Avenue and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project includes pavement rehabilitation of SW 9th Street from Emma Avenue to Leach Avenue, including scarification and removal of the top four (4) inches of Hot Mix Asphalt (HMA) pavement surface, patching defective sections of the existing concrete base, and HMA overlay with four (4) inches of HMA pavement.



## ADDITIONAL INFORMATION:

• On April 15, 2024, under Roll Call No. 24-0554, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the SW 9th Street Rehabilitation from Emma Avenue to Leach Avenue. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the SW 9th Street Rehabilitation from Emma Avenue to Leach Avenue, Activity ID 06-2024-008. The improvement includes street rehabilitation by milling the existing roadway, resurfacing with HMA, full depth Portland Cement Concrete (PCC) pavement patching, pavement markings, and other incidental items, all in accordance with the contract documents including Plan File No. 663-053/069 located on SW 9th Street from Emma Avenue to Leach Avenue.

- The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, IA, at 11:00 a.m. on May 7, 2024.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by TK Concrete, Inc. (Tony J. Ver Meer, President, 1608 Fifield Road, Pella, IA 50219) in the amount of \$575,841, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
- Construction of this project is anticipated to be completed by fall of 2024.
