AGENDA HEADING:

Ordering construction of the following: 2024 Hot Mix Asphalt (HMA) Resurfacing Program Contract 2 - Receiving bids, (6-18-24), and Setting date of hearing, (7-15-24). (Construction Estimate - \$750,000).

SYNOPSIS:

Recommend the City Council order construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project provides for the resurfacing of roadways, utilizing surface scarification and HMA overlay to improve the surface condition and to extend the useful service life of the streets.



ADDITIONAL INFORMATION:

- The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2024 HMA Resurfacing Program Contract 2, Activity ID 06-2024-013. The improvement includes scarification of existing asphalt streets, furnish and place HMA, furnish and place pavement markings, traffic control and other incidental items, all in accordance with the contract documents including Plan File No. 663-204/228 at the following locations and other locations directed by the City Engineer:
 - o Beaver Avenue from Hickman Road to Beaver Crest Road
 - o 2nd Avenue from Hull Avenue to Euclid Avenue
 - o Dean Avenue from E. 30th Street to E. 34th Street

- The estimated construction cost is \$750,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
- Construction of this project is anticipated to begin in summer 2024 and be completed in fall 2024, in accordance with the following completion provisions:
 - Construction work on the Beaver Avenue location shall be completed before September 14, 2024, or commence after September 22, 2024, to avoid conflicts with the Beaverdale Fall Festival.
 - O Construction work on the Dean Avenue location shall not commence before August 26, 2024, and shall be completed by November 1, 2024, to avoid conflicts with the Iowa State Fair.
