SYNOPSIS:

The Police and Public Safety Technology Departments recommend approval for the purchase of 20 Panasonic computers along with ancillary hardware, to replace existing mobile data equipment which reached the end of useful life. This equipment provides data and communication capabilities within police vehicles.

ADDITIONAL INFORMATION:

- The Police and Public Safety Technology Departments conducted a thorough analysis of available mobile computers from different providers. The analysis included failure rate, battery life, drop test ratings, along with numerous other specifications and it was determined that the best product to meet the needs of the department was the Panasonic FZ40AC-02AM. The computers will be purchased to replace mobile data computers which have reached the end of their useful life. The current computers will be re-purposed, when possible, for training and/or as an emergency back-up.
- The Panasonic FZ40AC-02AM is available under the NASPO Contract No. MNWNC-124. This
 allows the City to purchase the equipment from a contract that was established by a prior bidding
 process.
