AGENDA HEADING:

Hearing on Urbandale Avenue Resurfacing from 34th Street to Beaver Avenue: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as OMG Midwest, Inc. dba Des Moines Asphalt & Paving, Kevin Bragg, President, \$226,262.65.

SYNOPSIS:

This is a public hearing to allow for public input on the Urbandale Avenue Resurfacing from 34th Street to Beaver Avenue and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the resurfacing of Urbandale Avenue from 34th Street to Beaver Avenue, utilizing pavement scarification and Hot Mix Asphalt (HMA) overlay to improve the surface condition and to extend the useful service life of the street.



ADDITIONAL INFORMATION:

• On May 20, 2024, under Roll Call No. 24-0720, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Urbandale Avenue Resurfacing from 34th Street to Beaver Avenue. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Urbandale Avenue Resurfacing from 34th Street to Beaver Avenue, Activity ID 06-2024-014. The improvement includes scarification, furnish and place HMA pavement, pavement markings, manhole adjustments, traffic control, and other incidental items in accordance with the contract documents, including Plan File No. 663-101/113 located on Urbandale Avenue from 34th Street to Beaver Avenue.

- Sealed bids for said improvement were submitted by the following bidders:
 - o OMG Midwest, Inc. dba Des Moines Asphalt & Paving, Ankeny, IA Low Bid
 - o Grimes Asphalt and Paving Corporation, Des Moines, IA
 - o InRoads, LLC, Des Moines, IA
- The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, IA, at 11:00 a.m. on June 4, 2024.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by OMG Midwest, Inc. dba Des Moines Asphalt & Paving (Kevin Bragg, President, 2401 SE Tones Drive, Ste. 13, Ankeny, IA 50021) in the amount of \$226,262.65, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
- Construction of this project is anticipated to be completed by fall 2024.
