Recommend approval of the staff recommendation and the ordinance regarding the traffic regulation changes.


FISCAL IMPACT:

ADDITIONAL INFORMATION:

A. In order to provide additional metered parking on the north side of Locust Street between 4th Street and 5th Avenue, a taxicab stand is proposed to be removed. With changes to the Municipal Code in 2015 and 2016, taxicab stands no longer are necessary to solicit fares. The management of the Renaissance Savery Hotel, 401 Locust Street, was consulted regarding the potential removal of this taxicab stand and is in favor of the change. Upon review of the Municipal Code and field conditions for this segment of Locust Street, time-of-day parking restrictions need to be removed from the Municipal Code to match existing signed field conditions. The following revisions to the Municipal Code will place the recommended changes into effect.



Sec. 114-3422. Locust Street--Fourth Street to Fifth Avenue.

Locust Street, on the north side, from a point 25 feet west of Fourth Street to a point 60 feet east of Fifth Avenue, no parking 7:00 a.m. to 9:00 a.m.

Locust Street, on the north side, from Fourth Street to a point $25 \underline{40}$ feet west thereof, no parking any time.

Locust Street, on the north side, from a point $25 \underline{40}$ feet west of Fourth Street to a point $85-\underline{70}$ feet west thereof, loading zone. 9:00 a.m. to 7:00 a.m. the following day.

Locust Street, on the north side, from a point 110 feet west of Fourth Street to a point 80 feet west thereof, taxicab stand 9:00 a.m. to 7:00 a.m. the following day.

Locust Street, on the north side, from Fifth Avenue, to a point 60 30 feet east thereof, no parking any time.
