AGENDA HEADING:

Hearing on 2024 Hot Mix Asphalt (HMA) Resurfacing Program Contract 2: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as OMG Midwest, Inc., dba Des Moines Asphalt & Paving (Kevin Bragg, President) \$588,480.75.

SYNOPSIS:

This is a public hearing to allow for public input on the 2024 HMA Resurfacing Program Contract 2 and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the resurfacing of roadways, utilizing surface scarification and HMA overlay to improve the surface condition and to extend the useful service life of the streets.

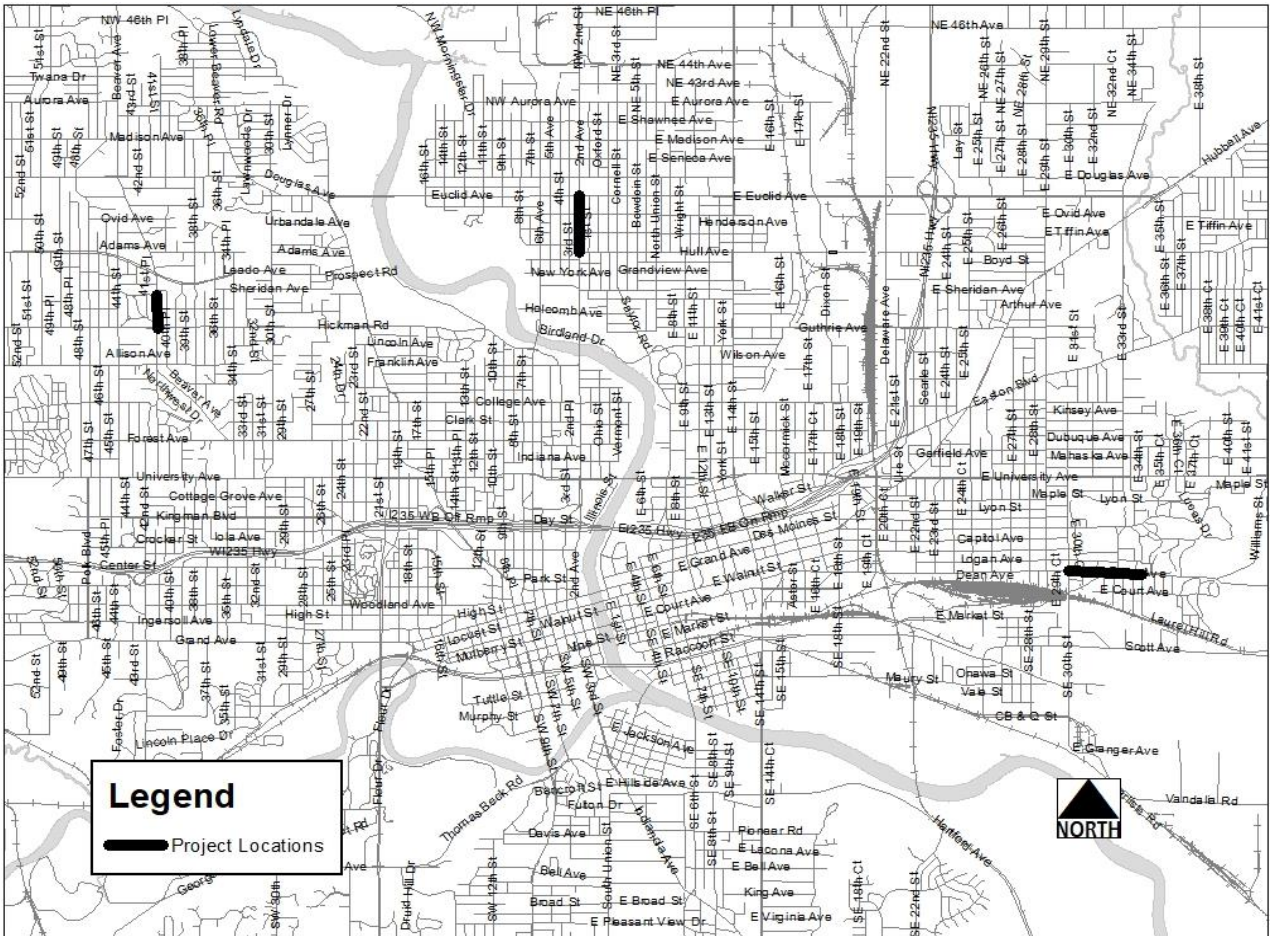
Amount: \$588,480.75 Construction Contract (\$750,000 City Engineer's Estimate)

Funding Source: Fiscal Year (FY) 2024-2025 Capital Improvement Program (CIP), Page 103, Roadway Rehabilitation – Collector, ST217, Gaming Monies

ADDITIONAL INFORMATION:

- On June 3, 2024, under Roll Call No. 24-0786, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2024 HMA Resurfacing Program Contract 2. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2024 HMA Resurfacing Program Contract 2, Activity ID 06-2024-013. The improvement includes scarification of existing asphalt streets, furnish and place HMA, furnish and place pavement markings, traffic control and other incidental items, all in accordance with the contract documents including Plan File No. 663-204/228 at the following locations and other locations directed by the City Engineer in Des Moines, Iowa:
 - Beaver Avenue - Hickman Road to Beaver Crest Road
 - 2nd Avenue - Hull Avenue to Euclid Avenue
 - Dean Avenue - E. 30th Street to E. 34th Street

- Sealed bids for said improvement were submitted by the following bidders:
 - OMG Midwest, Inc., dba Des Moines Asphalt & Paving, Ankeny, IA - Low Bid
 - InRoads, LLC, Des Moines, IA
 - Grimes Asphalt and Paving Corporation, Des Moines, IA
- The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, IA at 11:00 a.m. on June 18, 2024.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by OMG Midwest, Inc., dba Des Moines Asphalt & Paving (Kevin Bragg, President, 2401 SE Tones Drive, Ste. 13, Ankeny, IA 50021) in the amount of \$588,480.75, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
- Construction of this project is anticipated to begin in summer 2024 and be completed in fall 2024, in accordance with the following completion provisions:
 - Construction work on the Beaver Avenue location shall be completed before September 14, 2024, or commence after September 22, 2024, to avoid conflicts with the Beaverville Fall Festival.
 - Construction work on the Dean Avenue location shall not commence before August 26, 2024, and shall be completed by November 1, 2024, to avoid conflicts with the Iowa State Fair.
