AGENDA HEADING:

Recommend approval of the staff recommendation and the ordinance regarding the traffic regulation changes. Costs for sign installations and periodic maintenance of signs.



ADDITIONAL INFORMATION:


A. Staff received a request from a resident to sign an on-street accessible parking space on the east side of 33rd Street between College Avenue and Mondamin Avenue adjacent to his home. The property owner has met all the requirements in the City's Residential Handicap Parking Policy. The proposed code changes will provide one (1) accessible parking space on the east side of 33rd Street between College Avenue and Mondamin Avenue. The following changes to the Municipal Code are necessary to place these changes into effect.



Sec. 114-2880. Thirty-third Street--Woodland Avenue to Aurora Avenue.

Thirty-third Street, on the east side, from a point 155 feet north of College Avenue to a point 25 feet north thereof, is designated as handicapped parking spaces and are subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

B. Parking is currently restricted on both sides of E Broadway Avenue from the west city limits to the east city limits and no parking signage is in place. During a review of the Municipal Code in this area, it was found that this parking restriction is not shown in the Municipal Code. The proposed code modifications will place the parking restriction on E Broadway Avenue in the Municipal Code. The following modifications to the Municipal Code will place this change into effect.



Sec. 114-3033.0002 East Broadway Avenue—West city limits to east city limits.

East Broadway Avenue, on both sides, from the west city limits to the east city limits, no parking anytime.
