AGENDA HEADING:

Award bid to apply 73,500 square yards (SY) of asphalt rejuvenation product to various asphalt streets within the City of Des Moines, with Corrective Asphalt Materials, LLC, Anthony J Witte, President, \$101,084

SYNOPSIS:

Recommend approval of bid to apply asphalt rejuvenator to 73,500 square yards of full depth asphalt streets. This process will reduce future cracking and raveling of the asphalt, thereby extending the lifecycle of the street.

FISCAL IMPACT:

Amount: \$101,084

ADDITIONAL INFORMATION:

- In 2022, the Public Works Department contracted with Corrective Asphalt Materials to apply asphalt rejuvenator to over 250,000 square yards of asphalt streets. The test results from this project showed the application reduced the viscosity of the asphaltic cement in the pavement. This will lead to less cracking and less raveling over the lifecycle of the street. Less cracking and raveling will reduce potholes, essentially extending the useful life of the pavement.
- Five (5) potential bidders were identified, one (1) bid was received.
