Approve expansion of the Easter Lake Area Neighborhood boundaries in accordance with the Neighborhood Recognition Policy.

## SYNOPSIS:

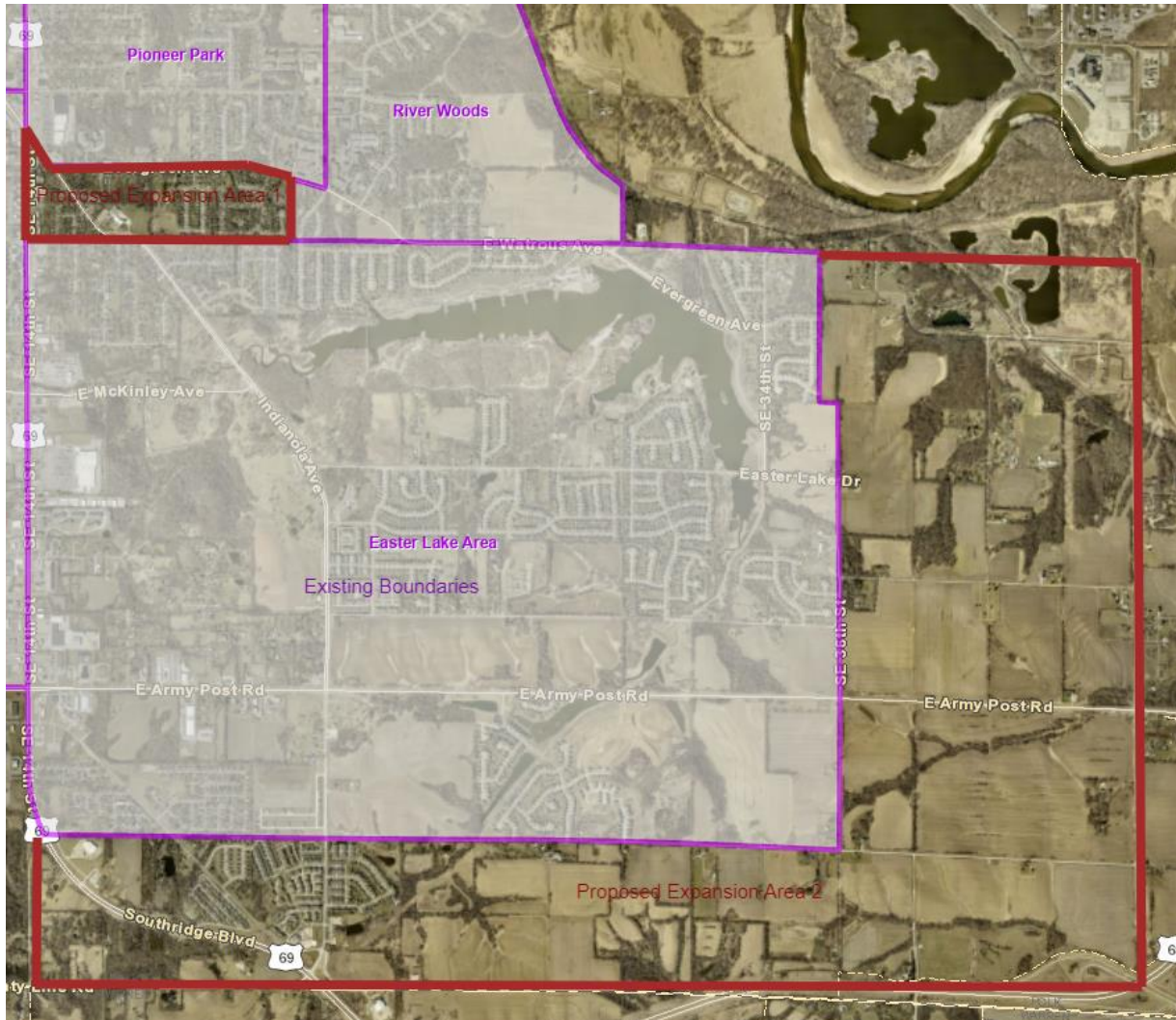
The Easter Lake Area Neighborhood Association requests approval of a proposed boundary expansion of the Easter Lake Area Neighborhood to include Indianola Avenue and Evergreen Avenue to the north, E Watrous Avenue to the South, SE 22<sup>nd</sup> Street to the east, and SE 14<sup>th</sup> Street to the west; and E Pine Avenue and E Watrous Avenue to the north, E County Line Road to the south, SE 45<sup>th</sup> Street to the east, and SE 14<sup>th</sup> Street to the west.

## ADDITIONAL INFORMATION:

- Boundaries for the proposed expansion includes two areas.
- The first area includes Indianola Avenue between SE 14<sup>th</sup> Street and Evergreen Avenue and Evergreen Avenue between Indianola Avenue and SE 22<sup>nd</sup> Street to the north, E Watrous Avenue between SE 14<sup>th</sup> Street and SE 22<sup>nd</sup> Street to the south, SE 22<sup>nd</sup> Street between Evergreen Avenue and E Watrous Avenue to the east, and SE 14<sup>th</sup> Street between Indianola Avenue and E Watrous Avenue. to the west.
- The second area includes: E Pine Avenue between SE 14<sup>th</sup> Street and SE 36<sup>th</sup> Street and E Watrous Avenue between SE 36<sup>th</sup> Street and SE 45<sup>th</sup> Street to the north, E County Line Road between SE 14<sup>th</sup> Street and SE 45<sup>th</sup> Street to the south, SE 45<sup>th</sup> Street between E Watrous Avenue and E County Line Road to the east, and SE 14<sup>th</sup> Street between E Pine Street and E County Line Road to the west.
- Existing boundary area:
  - North: E Watrous Avenue
  - South: E Pine Avenue
  - East: SE 36<sup>th</sup> Street
  - West: SE 14<sup>th</sup> Street

- Proposed boundary expansion to include (see map below):
  - North: Indianola Avenue/Evergreen Avenue/E Watrous Avenue
  - South: E County Line Road
  - East: SE 45<sup>th</sup> Street
  - West: SE 14<sup>th</sup> Street



- The proposed expansion area is not part of a recognized neighborhood association.
- The Easter Lake Area Neighborhood Association followed procedures for expansion in accordance with the Neighborhood Recognition Policy.
- The Easter Lake Area Neighborhood Association was originally recognized as the Allen/Bloomfield Neighborhood Association on May 16, 1994. On April 2, 2007, the association voted to change its name to Easter Lake Area Neighborhood Association. This name change was approved in accordance with the Neighborhood Recognition Policy and did not require action by the City Council.
