# AGENDA HEADING:

Accepting Inflation Reduction Act Grant Agreement with the United States Department of Agriculture (USDA) in the amount of \$2,500,000.

## SYNOPSIS:

Ratifying the acceptance of the Inflation Reduction Act Grant Agreement with the USDA, Forest Service, for \$2,500,000 of grant funding for the urban canopy expansion project and authorizing and directing City Manager to negotiate and approve related agreements with Trees Forever and Urban Ambassadors.

## FISCAL IMPACT:

Amount: \$2,500,000 in revenue

Funding: Forestry Operating Budget, PW245500

### **ADDITIONAL INFORMATION:**

- With the funds from the Inflation Reduction Act, Des Moines' tree canopy will receive an additional 4,000 6,000 trees within underserved communities highlighted by the Climate and Economic Justice Screening Tool (CEJST).
- Helping to meet Des Moines' tree canopy goals per the 2020 Urban Forestry Master Plan and to meet Iowa's Department of Natural Resources (DNR) goal of an overall three percent (3%) canopy increase by the year 2045.
- Partnering with two (2) local non-profits, Trees Forever and Urban Ambassadors, will be helping to plant a variety of tree sizes from 1.5" caliper inch trees to tree seedlings within public space.
- This project will be run over a period of five (5) years. The project will be administered by the Forestry Division, with oversight provided by other City departments (Finance, City Manager's Office, Legal, etc.).
