AGENDA HEADING:

Resolution approving the purchase of HPE Storage and Servers from OneNeck IT Solutions, per the State of Iowa Contract No. 2024-BUS-0117, NASPO Value Point Contract No. 23008 and City of Des Moines Short Form No. K24-572.

SYNOPSIS:

Recommend approval of the purchase of HPE Storage and Servers from OneNeck IT Solutions (11191 Aurora Avenue, Urbandale, IA 50322, Terry Swanson, President and CEO) per the State of Iowa Contract No. 2024-BUS-0117, NASPO Value Point Contract No. 23008, and City of Des Moines Short Form No. K24-572. This purchase will allow the Information Technology (IT) Department to move forward with the building out of the necessary data center storage and server infrastructure in the City's new data center facilities.

ADDITIONAL INFORMATION:

- City Facility Expansion is a multi-year strategic project to move several City departments, including the IT Department currently housed at the Argonne Armory Building, into the Cownie City Administration Building at 1200 Locust Street.
- Moving IT requires relocating the City's primary and secondary data centers to different data center facilities that are affordable, secure, resilient to natural or manmade hazards, and geographically diverse from each other and redundantly connected to City buildings by fiber optic network infrastructure.
- This purchase is for the HPE data center storage and server equipment required for both the colocation facility and the City Administration building that are part of the City Facility Expansion Project.
