### **AGENDA HEADING:**

Approving and authorizing the execution of a Cooperative Agreement between the Iowa Department of Transportation (IDOT) and the City of Des Moines for construction and maintenance of the Euclid Avenue Improvements from Des Moines River to York Street project.

## **SYNOPSIS:**

Recommend approval of the execution of a Cooperative Agreement between the IDOT and the City of Des Moines for construction and maintenance of the Euclid Avenue Improvements from Des Moines River to York Street project, which includes:

- O Hot Mix Asphalt (HMA) resurfacing of Euclid Avenue from the Des Moines River Bridge to York Street, including removal of existing HMA pavement surface by milling/scarifying to an average depth of three (3) inches and paving a new HMA pavement intermediate course and surface course to a total average depth of three (3) inches.
- o Providing a three (3)-lane cross section on Euclid Avenue (U.S. Highway 6) from the Des Moines River Bridge to 2nd Avenue. (Note: Curb and gutter changes with the three [3]-lane cross section will only be provided between 2nd Avenue and 12th Street.)
- Construction of curb extensions/bump outs at select intersections along Euclid Avenue from 2nd Avenue to 6th Avenue.
- Replacing and moving the curbs and gutters inward along Euclid Avenue between 6th Avenue and 12th Street to provide for the three (3)-lane cross section.
- O Construction of curb extensions/bump outs at the intersections of 6th Avenue and Clinton Avenue and 6th Avenue and Douglas Avenue.
- o Improving sidewalk curb ramps at intersections and adding missing sidewalk along the corridor to meet Americans with Disabilities Act (ADA) guidelines.
- Adding a midblock pedestrian crossing with a refuge island on Euclid Avenue between the intersections of 3rd Street and 4th Street, and between E. 12th Street and Wright Street.



<u>Funding Source</u>: Fiscal Year (FY) 2024-2025 Capital Improvement Program (CIP), Page 120, E. Euclid Avenue, ST284, Being: \$2,349,807 in IDOT Funds under Project No's NHSN-006-4(185)-2R-77 and NHSN-006-4(201)--2R-77, and the remaining \$2,700,193 in G.O. Bonds

## ADDITIONAL INFORMATION:

- The Euclid Avenue improvements from Des Moines River to York Street include:
  - O Hot Mix Asphalt (HMA) resurfacing of Euclid Avenue from the Des Moines River Bridge to York Street, including removal of existing HMA pavement surface by milling/scarifying to an average depth of three (3) inches and paving a new HMA pavement intermediate course and surface course to a total average depth of three (3) inches.
  - Providing a three (3)-lane cross section on Euclid Avenue (U.S. Highway 6) from the Des Moines River Bridge to 2nd Avenue. (Note: Curb and gutter changes with the three [3]-lane cross section will only be provided between 2nd Avenue and 12th Street.)
  - Construction of curb extensions/bump outs at select intersections along Euclid Avenue from 2nd Avenue to 6th Avenue.
  - Replacing and moving the curbs and gutters inward along Euclid Avenue between 6th Avenue and 12th Street to provide for the new three (3)-lane cross section.
  - o Construction of curb extensions/bump outs at the intersections of 6th Avenue and Clinton Avenue and 6th Avenue and Douglas Avenue.
  - o Improving sidewalk curb ramps at intersections and adding missing sidewalk along the corridor to meet ADA guidelines.
  - o Adding a midblock pedestrian crossing with a refuge island on Euclid Avenue between the intersections of 3rd Street and 4th Street, and between E. 12th Street and Wright Street.
- IDOT will provide funds for this project through the Pedestrian Curb Ramp Construction Program, a cooperative program to participate in the cost of constructing curb ramps on existing sidewalks within the rights of way of primary road extensions. IDOT will share eligible constructions costs in the ratio of 50% IDOT funds and 50% City funds with the maximum program funds available for this project being \$182,586.
- IDOT will reimburse the City for its share of the project costs, estimated at \$2,167,221, which include improvements requested by IDOT, including hot-mix asphalt resurfacing, that are not associated with implementation of the three (3)-lane cross section improvements.
- Sidewalk improvements at the intersections of Euclid Avenue and North Union Street, Euclid Avenue and East 8th Street, and Euclid Avenue and East 12th Street will be 100% IDOT cost.
- Costs for driveway removals and replacements located on the south side of Euclid Avenue between 16th Street and 14th Street will be shared equally between the City and IDOT at a 50%-50% ratio.

- Upon completion of construction, the City will assume responsibility for all future maintenance operations associated with this project, including:
  - Side road fillets
  - New parking areas along U.S. 6/Euclid Avenue between 6th Avenue and 2nd Avenue
  - Traffic Signals
  - o Sidewalks and curb ramps
  - o Fire hydrant
  - o Retaining walls
  - Landscape rock
  - o Colored curb and gutter
  - Concrete stairs with handrails
- Construction of this project is anticipated to start in spring 2025 and reach completion in fall 2025.
