AGENDA HEADING:

Approval of grant agreements with the U.S. Department of Housing and Urban Development (HUD) for funding of the City's 2024 Action Plan, which is the fifth year of the 2020-2024 Consolidated Plan

SYNOPSIS:

HUD designates annual formula funding, also known as entitlement funds, to the City of Des Moines. Grant programs under the formula funding include Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME) Program, and Emergency Solutions Grant (ESG). This action is to execute the annual agreement for CDBG only, which enables the City to access the grant funds. The HOME and ESG agreements were approved at the November 18, 2024 Council meeting.

ADDITIONAL INFORMATION:

- The primary objective of the CDBG program is the development of viable urban communities by providing decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low- and moderate-income.
