

- This project provides for the paving of residential streets utilizing surface scarification and HMA to extend the useful service life of streets at the following locations:
 - o S.E. 5th Street from E. Bell Avenue to Pioneer Road
 - o Lincoln Avenue from Merle Hay Road to Merklin Way
 - o 57th Street from Forest Avenue to Clark Boulevard
 - Ovid Avenue from 56th Street to 54th Street
 - o Reynolds Lane from Farwell Road to Arthur Avenue
 - o Farwell Road from Tomlin Lane to Hubbell Avenue
 - o Tomlin Lane from Guthrie Avenue to Arthur Avenue
 - o Arthur Avenue from Lay Street to Farwell Avenue
 - o Arthur Avenue from dead end west of Farwell Road to Reynolds Lane
 - o Mahaska Avenue from E. 38th Street to E. 40th Street

- O Dubuque Avenue from Hubbell Avenue to E. 24th Street
- o 58th Street from Chamberlain Drive to Kingman Avenue
- o 37th Street from Beaver Avenue to Washington Avenue
- o E. Washington Avenue from E. 22nd Street to Lay Street

- On March 27, 2023, under Roll Call No. 23-0444, the City Council approved plans and specifications for 2023 HMA Residential Paving Program Contract 1 LOSST and designated the lowest responsible bidder as Grimes Asphalt and Paving Corporation for \$1,051,150.78.
- Change Order No. 1 for \$98,900, approved by the City Engineer on December 7, 2023, added asphalt quantities for Davisson Road.
- Change Order No. 2 for \$99,538.50, approved by the City Engineer on January 25, 2024, added sidewalks and Americans with Disabilities Act (ADA) Ramps, concrete retaining wall at SE 5th Street and E. Bell Avenue, concrete island, and quantities for traffic control signs and Portland Cement Concrete (PCC) curb and gutter.
- Change Order No. 3 includes removal and installation of six (6)-inch PCC curb and gutter with special shaping that was discovered to be needed during construction of the project at 37th Street and SE 5th Street and will also adjust quantities to match as-built quantities.
