# AGENDA HEADING:

Public hearing for approval of the application to Iowa Economic Development Authority (IEDA) for Community Development Block Grant (CDBG) funds to prepare for, prevent, and respond to coronavirus (CDBG-CV).

### **SYNOPSIS:**

The State of Iowa received \$9.5 million in CDBG-CV funds from the US Department of Housing and Urban Development (HUD). The City of Des Moines has fully expended its first allocation from the State and has the opportunity to request more funding.

## FISCAL IMPACT:

Amount: \$2 million

Funding Source: HUD, as passed through IEDA

### **ADDITIONAL INFORMATION:**

• In the height of the coronavirus pandemic, the City of Des Moines received three (3) rounds of CDBG-CV funds and two (2) rounds of Emergency Shelter Grant (ESG-CV) funds.

- CDBG-CV Rounds 1 and 3 were directly from HUD. Round 2 was passed through from the State of Iowa. ESG-CV funds were directly from HUD. Additionally, the City received approximately \$11.5 million of Emergency Rental Assistance Program (ERAP) from the US Treasury for COVID response.
- Previous activities funded in the first CDBG-CV allocation from IEDA included housing subsistence payments, mental health services, and childcare expansion.
- The proposed use of the CDBG-CV funds is for a pallet shelter village concept for emergency shelter. A public notice was posted to the City's web site with details. A summary of some of the public notice and the project is below.
  - Pallet shelters are non-congregate, separate shelter units.
  - Pallet shelters are made from fiberglass, are secured to the ground, and have a minimum 20-year lifespan.
  - They are movable and re-deployable if needed.
- The need for the project was initially intended as emergency family shelter units. The shelter units will now be for individuals rather than families.
- All activities will take place in the City of Des Moines jurisdiction. The proposed site is 2501 Maury Street, also known as the Chesterfield Community Center site. The location may change if it does not pass HUD's environmental review process.
