AGENDA HEADING:

Approving the purchase of cardio and weight equipment for Des Moines North Side Community Recreation Center from Push Pedal Pull, Inc., approving use of Sourcewell Contract No. 052324-PCR, and authorizing negotiation and execution of Supplemental Agreement with Push Pedal Pull, Inc.

SYNOPSIS:

Recommend approval of purchase of cardio and weight equipment and installation services from Push Pedal Pull, Inc. (2306 W. 41st Street, Sioux Falls, SD 57105; Martin Bruder, President) for the Des Moines North Side Community Recreation Center, subsequently to be known as the Reichardt Community Recreation Center, in the amount of \$112,144, using Sourcewell Contract No. 052324-PCR.

FISCAL IMPACT:

Amount: \$112,144

Funding Source: Fiscal Year (FY) 2024-2025 Capital Improvement Program (CIP), Page 52, Northside Community Recreation Center, BL135, Being: G.O. Bonds, Local Option Sales and Service Tax (LOSST), General Fund via American Rescue Plan Act (ARPA) transfer, and Private Funds

ADDITIONAL INFORMATION:

- Construction of the Des Moines North Side Community Recreation Center, subsequently to be known as the Reichardt Community Recreation Center, is underway and is expected to be substantially complete in spring 2026.
- The cardio and weight equipment required to complete the facility were intentionally omitted from the construction contract, thereby allowing the City to procure these items directly and benefit from the discounts offered through existing cooperative purchasing agreements.
- An allowance of funds has been reserved within the BL135 Northside Community Recreation Center project for City arranged procurement of fixtures, furnishings, and equipment (FF+E) items, such as these.

- Push Pedal Pull, Inc. is able furnish and install the necessary cardio and weight equipment using the discounts, terms and conditions of Sourcewell Contract No. 052324-PCR for a quoted amount of \$112,144.
