AGENDA HEADING:

Ordering construction of the following: 2025 Sidewalk and Pedestrian Ramp Replacement Program - Receiving bids, (2-25-25), and Setting date of hearing, (3-10-25). (Construction Estimate - \$436,000).

SYNOPSIS:

Recommend the City Council order construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project provides for a citywide program to replace deteriorated City sidewalks, Americans with Disabilities Act (ADA)-compliant sidewalk ramps, sidewalks damaged by City activities or by City trees in the public right-of-way, and sidewalks for residents that qualify for the City's special assessment subsidy program.



ADDITIONAL INFORMATION:

- The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2025 Sidewalk and Pedestrian Ramp Replacement Program, Activity ID 09-2025-001. The improvement includes reconstruction of brick sidewalks, Class A and Class B Portland Cement Concrete (PCC) sidewalks of varying thickness including all appurtenances, PCC ADA-compliant curb ramps, all in accordance with the contract documents at various locations directed by the City Engineer.
- The estimated construction cost is \$436,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
- Construction of this project is anticipated to commence in spring and be completed in winter 2025.
