### AGENDA HEADING:

Resolution approving First Amendment to Urban Renewal Development Agreement between the City of Des Moines and Hilltop Housing, LLC for Hilltop III and Hilltop IV allowing for an extension of Article 1, Section 1.2 “Time for Completion of Improvements”.

### SYNOPSIS:

On April 19, 2021, Hilltop Housing, LLC (J.B. Conlin, Colin Properties, 3721 SW 61st Street, Des Moines, IA 50321) entered into an urban renewal agreement with the City of Des Moines for the construction of two (2) multi-family apartment buildings, consisting of a 42-unit family apartment building and a 42-unit senior apartment building, located in the vicinity of 3600 Hubbell Avenue at the Hilltop Apartments site. Total construction cost is estimated at \$17.1 million. Hilltop Housing, LLC will be applying for housing tax credits from the Iowa Finance Authority (IFA) in April of 2025.

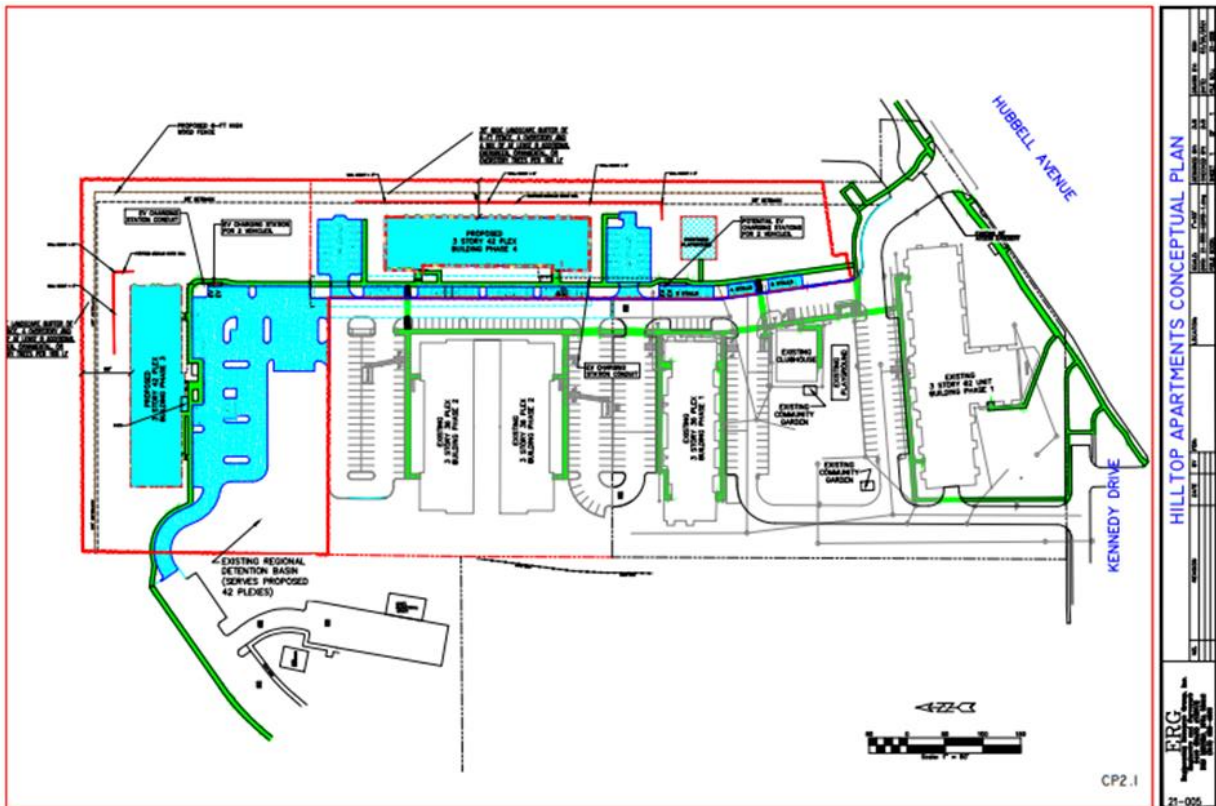
Hilltop Housing, LLC has asked for and staff is recommending a one (1)-year extension for Article 1, Section 1.2 “Time for Completion of Improvements.” Improvements shall now be substantially completed by December 31, 2027, to qualify for the issuance of the Certificate of Completion.

### ADDITIONAL INFORMATION:

- Due to the timing of securing anticipated approvals for housing tax credits through IFA, a one (1)-year extension is being requested.
- The development parcel is located in the 3600 block of Hubbell Avenue and is currently vacant.
