AGENDA HEADING:

Hearing on E. Euclid Avenue Sidewalk From East of E. 14th Street to Union Pacific Railroad: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as C-2 Creative Concrete, LLC (Abigail Needham, Owner), \$239,940.

SYNOPSIS:

This is a public hearing to allow for public input on the E. Euclid Avenue Sidewalk From East of E. 14th Street to Union Pacific Railroad and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. The project includes the installation of sidewalk on the south side of E. Euclid Avenue from 1515 E. Euclid Avenue to 1641 E. Euclid Avenue and reconstructs existing brick sidewalks on Fremont Street between E. 13th Street and E. 14th Street.



ADDITIONAL INFORMATION:

• On January 27, 2025, under Roll Call No. 25-0094, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the E. Euclid Avenue Sidewalk From East of E. 14th Street to Union Pacific Railroad. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the E. Euclid Avenue Sidewalk From East of E. 14th Street to Union Pacific Railroad, Activity ID 09-2024-006. The improvement includes Portland Cement Concrete (PCC) sidewalk and driveways, brick paver sidewalks, pavement removal, storm sewer, temporary traffic control, erosion control, surface restoration, and other incidental items, all in accordance with the contract documents including Plan File No. 672-194/206, located along E. Euclid Avenue between E. 14th Street and Union Pacific Railroad crossing, and along Fremont Street between E. 13th Street and E. 14th Street.

- Sealed bids for said improvement were submitted by the following bidders:

- The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, IA at 11:00 a.m. on February 11, 2025.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by C-2 Creative Concrete, LLC (Abigail Needham, Owner; 1567 Grand Drive, Unit 1, Dekalb, IL 60115) in the amount of \$239,940, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
- Construction of this project is anticipated to be fully completed in fall 2025. All work associated with Fremont Street, except installation of sod, shall be completed within 25 calendar days while school is out of session in summer 2025.
