AGENDA HEADING:

First consideration to amend Chapter 46 of the Municipal Code to allow private streets to serve as compliant fire access roads.

SYNOPSIS:

Approval of this action amends Chapter 46 of the Municipal Code by allowing for private streets to serve as fire access roads. Previously when two (2) or more fire access roads were required for single or multi-family developments, those streets were required to be public streets. This amendment allows for private streets (designed appropriately and meeting fire code requirements) to meet this requirement. This will provide developers with greater flexibility when designing new developments.
