AGENDA HEADING:

Approving the purchase of lighting to be installed on the Linda and Thomas Koehn Boardwalk at MacRae Park from Baker Group at a total cost of \$109,661, approving use of State of Iowa contract MA20448B, and authorizing negotiation and execution of supplemental agreement with Baker Group.

SYNOPSIS:

Recommend approval of the purchase and installation of lighting on the Linda and Thomas Koehn Boardwalk at MacRae Park from Baker Group (1600 S.E. Corporate Woods Drive, Ankeny, IA 50021; Doug Kumm, President) at a total cost of \$109,661. The purchase utilizes pricing from State of Iowa Contract MA20448A. Lighting will enhance the boardwalk's functionality and visibility while offering programmable color schemes to engage the public.




ADDITIONAL INFORMATION:

- The Linda and Thomas Koehn Boardwalk was constructed in 2022 as part of the Phase 3 improvements to MacRae Park.
- A ribbon cutting ceremony for MacRae Park Phase 3 was held on Wednesday, June 28, 2023, to celebrate the park's new multiuse trail, pedestrian bridge, boardwalk, enhanced fishing areas, open-air shelter, custom nature playscape, including a playground and sprayground, and reconstructed park road with storm sewer, parking, and accessibility upgrades.
- The proposed boardwalk lighting system is partially funded with \$20,000 from the 2024 Prairie Meadows Community Betterment Grant program.
- The proposed lighting will enhance aesthetics, visibility, awareness, and extended usage of the boardwalk and MacRae Park.

- The proposed lighting includes programmable color-changing capabilities for programming seasonal and event-themed illumination.
- The Procurement Division has determined the equipment and installation are available through competitively bid State of Iowa Contract MA20448A.
- Pursuant to Des Moines Municipal Code Section 2-726(b)(18), the City may procure goods/services from state-established contracts without further competitive bidding.
- The City will enter into a supplemental agreement with Baker Group to execute the project under the State contract.
