AGENDA HEADING:

Approving Change Order No. 1 with TNT Tuckpointing and Building Restoration, LLC, for additional work on Fort Des Moines Historic Monument Replacement, in the amount of \$107,692.68.

SYNOPSIS:

Recommend approval of Change Order No. 1 in the amount of \$107,692.68 with TNT Tuckpointing and Building Restoration, LLC, Joshua L. Smyser, Owner, 202 Iowa Street, Stockton, Iowa 52769, for additional work on Fort Des Moines Historic Monument Replacement.



ADDITIONAL INFORMATION:

- This project includes removal and replacement of the damaged south monument and repointing and cleaning of the north monument, located at historic Fort Des Moines on the east side of SW 9th Street at Bundy Street.
- On July 14, 2025 under Roll Call 25-0960, the City Council held a hearing on the Fort Des Moines Historic Monument Replacement, and approved plans, specifications, form of contract documents, engineer's estimate, received and filed bids, and designated the lowest responsible bidder as TNT Tuckpointing and Building Restoration, LLC for \$122,680.
- While TNT Tuckpointing and Building Restoration, LLC was under contract for the SW 9th
 Street at Bundy Street location, a second stone monument was damaged in a car accident at
 Army Post Road and Chaffee Road. Change Order No. 1 will add the second location to the
 original contract for reconstruction of the historic monument at Army Post Road and Chaffee
 Road.
- Change Order No. 1 is for a new concrete backer wall, new stone, and cap stones to match the existing monuments and of similar design to the SW 9th Street at Bundy Street monument.
