

ADDITIONAL INFORMATION:

- The Parks and Recreation Department requested the Finance Department, Procurement Division to solicit bids for Parks Signage Fabrication and Installation Services, Phase 11.
- The Procurement Division solicited bids by publishing Request for Bid D25-419 on the City's online bid procurement system with 20 potential bidders and received one (1) bid.
- The Procurement Administrator and the Parks and Recreation Department recommend approval of the low-dollar compliant bid from Eagle Sign Co., subject to terms of Request for Bid D25-419.
- Parks signage contributes to the overall character of the parks and recreation system, it is a valuable component of the identity of an individual facility and is also a critical safety feature for first responders and the public to understand the location they are at or need to go.
- The purchase includes fabrication, permitting and installation of approved City of Des Moines Parks and Recreation signage that complies with City Code. Phase 11 will include new signage at Allen Park, Kathryn Krieg Park, Ewing Dog Park, Riverwalk Dog Park, Sayers Park, Bob Mahaffey Shelter at Grandview Park, Sheridan Park and Union Park and repair of the Pete Crivaro Park sign.
