Approval of the Fiscal Year (FY)2025 Annual Federal Equitable Sharing Agreement and Certification report.

SYNOPSIS:

The Police department recommends approval of the Annual Federal Equitable Sharing Agreement and Certification report for FY2025. The submission of this annual report is required by the Department of Justice (DOJ) who administers the program and will allow the Police Departments to continue to participate in the sharing of federal asset forfeiture funds.

FISCAL IMPACT:

Amount: Revenue varies from year to year depending on activity and the rate of interest. In FY25, the revenue generated from forfeited funds was \$134,140.26. The Police Department spent \$204,187.60 to attend various job-related training and replace expired equipment throughout the year.

<u>Funding Source</u>: SP321 PD225000, Federal Forfeited Funds, printed page 218 of the FY25 Approved Budget document.

ADDITIONAL INFORMATION:

This report verifies proper use of the federal asset forfeiture funds in accordance with the DOJ rules and regulations. These regulations stipulate that the funds must be used to enhance law enforcement activities and must not be used to replace or supplant the budgeted resources of the law enforcement agency.
