AGENDA HEADING:

Hold public hearing on proposed issuance of Series 2025A Bonds and Taxable Series 2025B for essential corporate (ECP), urban renewal (UR), general corporate (GCP) purposes for the fiscal year (FY) 2026 Capital Improvement budget and adopting additional action on the authorization and issuance of said bonds.

SYNOPSIS:

Hold public hearings and direct notices regarding the issuance of Not to Exceed (NTE) \$71.82M for the Series 2025A and \$6.17M for the Series 2025B Taxable for the approved Capital Improvement Plan.

The bonds or capital loan notes are to be used to fund the Capital Improvement Plan approved by Council on April 7, 2025.

FISCAL IMPACT:

Amount: Anticipated total issuance is \$71,820,000 for the Series 2025A and \$6,170,000 for the Series 2025B Taxable Issuance.

Funding Source: FY 2025 - FY 2029 Capital Improvement Plan

ADDITIONAL INFORMATION:

ECP – NTE \$38M GO Bonds or Capital Loan Notes

The acquisition, construction, reconstruction, enlargement, improvement, and repair of bridges, culverts, retaining walls, viaducts, underpasses, grade crossing separations, and approaches thereto; rehabilitation and improvement of parks already owned, including the removal, replacement and planting of trees in the parks, and facilities, equipment, and improvements commonly found in city parks; equipping of fire department; acquisition and improvement of real estate for cemeteries, and the construction, reconstruction, and repair of cemetery facilities; opening, widening, extending, grading, and draining of the right-of-way of streets, highways, avenues, alleys, public grounds, and market places, and the removal and replacement of dead or diseased trees thereon; construction, reconstruction, and repairing of any street improvements; acquisition, construction, reconstruction, improvement, repair, and equipping of waterworks, water mains, and extensions, and real and personal property, useful for providing potable water to residents of a city; acquisition, installation, and repair of traffic control devices; acquisition, construction, improvement, and installation of street lighting fixtures, connections, and facilities; construction, reconstruction, and repair of sidewalks and

pedestrian underpasses and overpasses; and the acquisition of real estate needed for any of the foregoing purposes; acquisition, restoration, or demolition of abandoned, dilapidated, or dangerous buildings, structures or properties or the abatement of a nuisance; and the establishment and funding of programs to provide for or assist in providing for the acquisition, restoration or demolition of housing, as part of a municipal housing project.

For aiding in the planning, undertaking and carrying out of urban renewal projects in accordance with Iowa Code chapter 403 and the urban renewal plans for the Ingersoll-Grand Commercial Urban Renewal Area, Metro Center Urban Renewal Area, Central Place Industrial Park Redevelopment Program Urban Renewal Area, and SE Agribusiness Urban Renewal Area, as amended, including the Central Iowa Water Trails, Downtown Restroom project, Principal Park improvements, and various public improvement projects involving street, streetscape, bridge, sidewalk, skywalk, pedestrian signage, utility and park and recreation improvements, with related site improvements.
