AGENDA HEADING:

1. Approving the purchase of two (2) replacement purpose-built, Elgin Pelican three-wheeled, mechanical broom street sweepers for use by the Street Cleaning Division of the Public Works Department.

SYNOPSIS:

1. Recommend approval to purchase two (2) replacement purpose-built, Elgin Pelican three-wheeled, mechanical broom street sweepers from MacQueen Group utilizing Sourcewell contract #093021-ELG.

Per Sourcewell contract #093021-ELG with Elgin Street Sweeper Company, 1300 West Bartlett Road, Elgin, IL 60120; David Panizzi, Business Development Manager and local dealer MacQueen Group, 4607 SE Rio Ct., Ankeny, IA 50021; Mike Osler, Director of Sales in the amount of \$645,031 for two (2) 2025 Elgin Pelican three-wheeled, mechanical broom street sweepers, NP Dual Gutter Broom Tier 4F Model. Sourcewell contract pricing is MSRP minus 3% discount for a total of \$322,515.50 per machine. The total contract request for two machines is \$645,031.00.

2. Public Works Department will use the street sweeping units for routine scheduled street cleaning and in collaboration with the Parks and Recreation Department for facility street and parking lot cleaning. This purchase will replace two (2) current units that meet the annual vehicle acquisition board replacement criteria.

FISCAL IMPACT:

Amount: \$645,031.00

Funding Source: Fiscal Year (FY) 2025-2026 Recommended Operating Budget, Page 78, Equipment Replacement Fund

ADDITIONAL INFORMATION:

The requested purchase was considered as part of the annual vehicle acquisition board and are recommended for Council consideration.

The current machines requested for replacement include:

- a. 2011 Elgin model with 6,024 hours of use that was approved for purchase on June 13, 2011 for a total cost of \$162,816 (per machine).
- b. 2017 Elgin model with 5,559 hours of use that was approved for purchase on June 26, 2017 for a total cost of \$249,810 (per machine).

Street sweepers are deployed daily during two (2) operational shifts to sweep planned and scheduled residential streets and business areas. Criteria for replacement is five (5) years or 5,000 hours. Units being replaced will be auctioned through the City's contractor for disposal of used equipment.

Street sweepers are essential for leaf sweeping during the fall season as a preventative measure to keep leaves from entering the storm sewer system.
