Amendments to Schedule of Fees for application fees collected by the City's Development Services Department.

SYNOPSIS:

The Development Services Department is proposing updates to the City's Schedule of Fees that would ensure fees collected by the Development Services Department will better cover the costs of services provided by the Development Services Department.

FISCAL IMPACT:

Amount: Application fee increases are estimated to increase the Development Services Department's revenue by approximately three percent (3%).

<u>Funding Source</u>: Application Fees charged for services provided by the Development Services Department.

ADDITIONAL INFORMATION:

- <u>Planning and Urban Design Processes</u>: The proposed updates to the Schedule of Fees would increase the application fees collected for planning and zoning processes by approximately three percent (3%). The proposed updates also simplify the application fees charged for Site Plans, Site Plans Amendments, and Legacy Planned Unit Development District amendments.
- <u>Permit and Development Processes</u>: The proposed updates to the Schedule of Fees would increase the application fees collected for permit and development processes by approximately three percent (3%). The proposed updates also establish a building permit fee for new construction of an accessory structure with living quarters.
