AGENDA HEADING:

Authorization of the Food Sustainability Advisory Committee (FSAC).

SYNOPSIS:

The City of Des Moines has had two (2) previous iterations of a Food Security Task Force, which focused on providing information and resources to residents to help them grow their own food, as well as ordinance changes to support urban agriculture. This new Committee will build on the work of the previous two (2) Task Forces, focusing on ways that the City can promote a sustainable food system through land use, ordinances/policies, and partnerships with urban agriculture organizations.

FISCAL IMPACT: NONE

ADDITIONAL INFORMATION:

- Upon dissolution of the Sustainability Office in January 2025, the City Manager's Office focused on identifying initiatives to continue and distribute the Office's work into other Department/ Division operations.
- The City Manager's Office had a strong desire to see the work of the Food Security Task Force continue as a way to meet goals outlined within ADAPT DSM, the City's climate action plan, and continue to grow a sustainable food system in the face of a changing climate and continued growth in uncertainty related to food access.
- Office of Economic Development staff have been identified as ideal to carry forward work relating
 to developing a sustainable food system. These staff often answer questions related to land use and
 entrepreneurship involving food production, have a positive working relationship with various
 community organizations focused on sustainable food production, and facilitated the City's Drake
 Park Orchard Planting Project executed in fall 2025.
- Office of Economic Development staff will serve as the City staff liaisons for this new Committee, which will run indefinitely. Committee members will be selected based on subject matter expertise.
- This Committee will meet monthly and will work with City staff to bring forward recommendations to the City Manager's Office and/or City Council for policies and actions that the City can develop or adapt to promote food production and a sustainable food system. The Committee will initially

focus on the utilization of City assets and resources that could strengthen the local food system – land access/City land use, promotion of food production into existing City operations/policies, and communications platforms/programming.

• The Committee will be supplemented by an internal City staff working group on food sustainability that will serve as an implementation arm of the external-facing Committee.
