AGENDA HEADING:

Approving Change Order No. 3 with Hydro-Klean, LLC for additional work on 2025 Sewer Lining Program, in the amount of \$158,867.04.

SYNOPSIS:

Recommend approval of Change Order No. 3 in the amount of \$158,867.04 with Hydro-Klean, LLC (Wade Anderson, President; 333 NW 49th Place, Des Moines, Iowa 50313) for additional work on 2025 Sewer Lining Program.



<u>Funding Source</u>: Fiscal Year (FY) 2025-2026 Capital Improvement Program (CIP), Page 107, Sanitary Sewer Lining and Repairs, SS049, Sanitary Sewer Funds

ADDITIONAL INFORMATION:

- This project provides for the rehabilitation of sanitary and storm sewers that have not yet failed but are in an advanced state of deterioration due to age, with some up to 100 years old, including over 22,000 lineal feet of cured-in-place pipe (CIPP) lining (trenchless sewer rehabilitation) at 47 locations. Lining of sewers has proven to be a cost effective and less disruptive method for rehabilitating deteriorated sewers compared to excavating and replacing them with new sewers.
- On February 24, 2025, by Roll Call No. 25-0298, City Council held a hearing on 2025 Sewer Lining Program, approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating the lowest responsible bidder as Hydro-Klean, LLC for \$3,399,004.54.
- Change Order No. 1 for \$26,350, approved by the City Engineer on August 13, 2025, was for utilizing heavy duty equipment to clean a large amount of debris including large quantities of bricks that were encountered.
- Change Order No. 2 for \$48,915.78, approved by the City Engineer on November 6, 2025, added a Short Liner to be placed at an emergency repair on Thompson Avenue to stabilize the area for a full liner to be installed.

• Change Order No. 3 includes storm sewer work, including installation of new storm sewer and storm intakes and repaying the intersection to alleviate flooding at the 18th Street and Grand Avenue intersection.
