### AGENDA HEADING:

Ordering construction of the following: Southeast (SE) Industrial Water Main – East (E) Army Post Road and SE 45th Street - Receiving bids, (1-27-26), and Setting date of hearing, (2-23-26). (Construction Estimate - \$3,150,000).

### SYNOPSIS:

Recommend the City Council order construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project includes the installation of a 12-inch and 16-inch water main for the SE Des Moines Industrial Park located along Hart Avenue from SE 36th Street to SE 45th Street, SE 45th Street from Hart Avenue to Pine Avenue, Army Post Road from 1,300 ft west of SE 45th Street to SE 45th Street, and Pine Avenue from SE 36th Street to SE 45th Street.

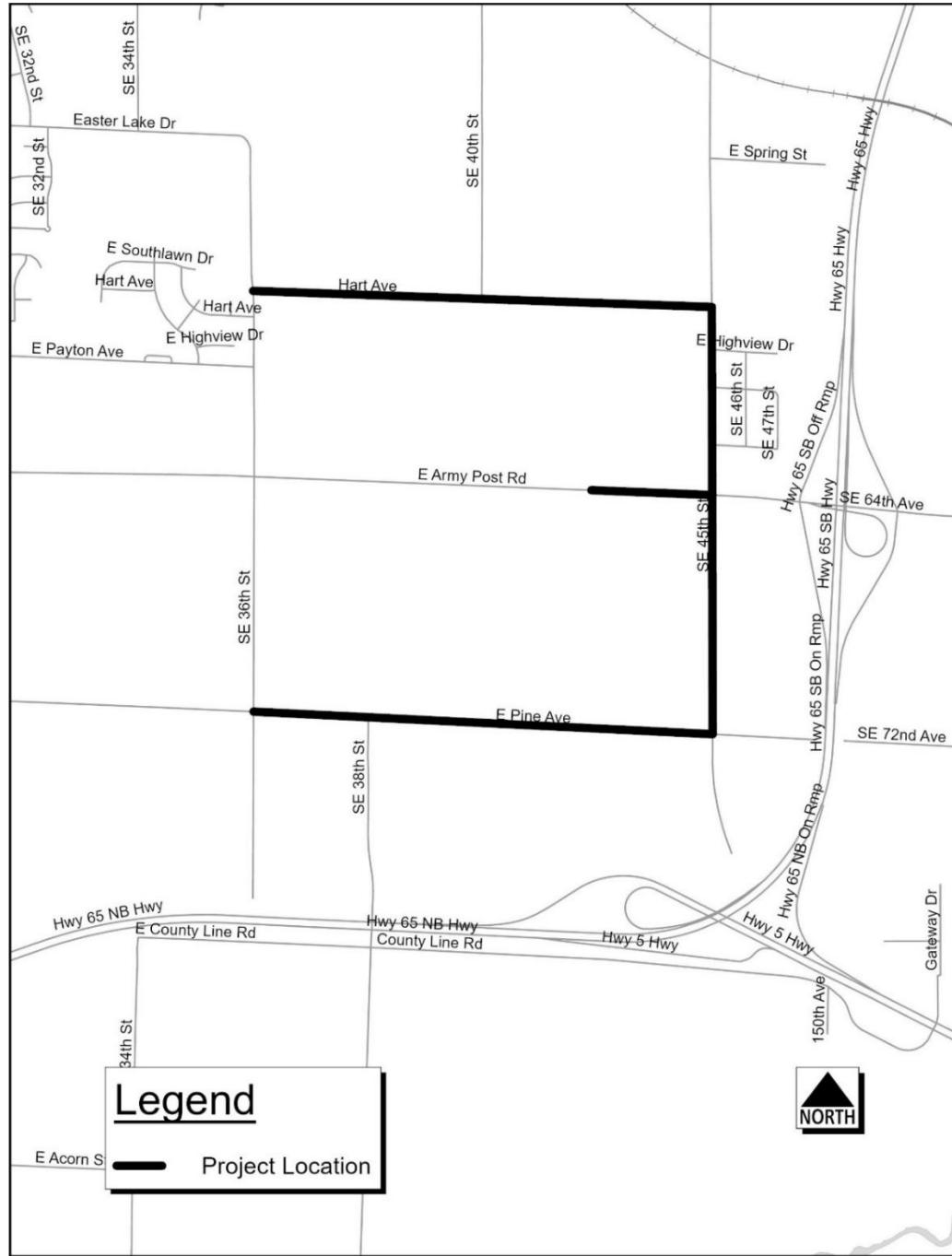

### ADDITIONAL INFORMATION:

- The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the SE Industrial Water Main - E Army Post Road and SE 45th Street, Activity ID 04-2026-008. The improvements include trenched and trenchless 12-inch and 16-inch water main installation, water service installation, partial culvert removal and replacements, full depth patching, Portland Concrete Cement (PCC) Driveways, Hot-Mix Asphalt (HMA) driveways, gravel driveways, seeding, erosion control, pavement markings, and other incidental items, all in accordance with the contract documents including Plan File No. 678-447/528, located on Hart Avenue from SE 36th Street to SE 45th Street, SE 45th Street from Hart Avenue to Pine Avenue, Army Post Road from 1,300 feet west of SE 45th Street to SE 45th Street, and Pine Avenue from SE 36th Street to SE 45th Street.
- The estimated construction cost is \$3,150,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.

- Upon completion of the improvement, the water main will be conveyed to the Des Moines Water Works.
- This project is anticipated to begin in spring 2026 and be completed in spring 2027.
