AGENDA HEADING:

Ordering construction of the following: Beaver Avenue Resurfacing from Franklin Avenue to Douglas Avenue - Receiving bids, (2-10-26), and Setting date of hearing, (3-9-26). (Construction Estimate - \$920,000).

SYNOPSIS:

Recommend the City Council order construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project includes pavement resurfacing of Beaver Avenue from Franklin Avenue to Hickman Road and of Beaver Avenue from Fagen Drive to Douglas Avenue. The resurfacing includes milling to remove the existing asphalt surface, patching, and Hot-Mix Asphalt (HMA) overlay to improve the surface condition, and to extend the useful service life of the streets.


FISCAL IMPACT:

Amount: \$920,000 City Engineer's Estimate

ADDITIONAL INFORMATION:

- The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Beaver Avenue Resurfacing from Franklin Avenue to Douglas Avenue, Activity ID 06-2025-014. The improvement includes scarification, furnish and placement of Hot-Mix Asphalt (HMA) pavement, pavement markings, manhole adjustments, traffic control, signage and other incidental items, all in accordance with the contract documents including Plan File No. 679-125/147, located along Beaver Avenue from Franklin Avenue to Hickman Road and on Beaver Avenue from Fagen Drive to Douglas Avenue.
- The estimated construction cost is \$920,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
- This project is anticipated to begin in spring 2026 and be completed in fall 2026.
