AGENDA HEADING:

Set date of public hearing on the proposed Sixth Amendment to the Urban Renewal Plan for the Oak Park – Highland Park Urban Renewal Area.

SYNOPSIS:

This roll calls sets the date of public hearing on the proposed Sixth Amendment to the Urban Renewal Plan for the Oak Park – Highland Park Urban Renewal Area for the April 20, 2026, City Council meeting and authorizes the required consultation meeting with representatives from Polk County, Des Moines Public Schools, Des Moines Area Community College, and Des Moines Area Regional Transit.
