02-1785 (A) First consideration of ordinance regarding resident parking restrictions. **Moved by Cownie that this ordinance be considered and given first vote for passage, as amended, to allow resident parking from 6:00 P.M. to 7:00 A.M. Motion Carried 6-1. Absent: Daniels.**
