

ORDINANCE NO. 13,592

AN ORDINANCE to amend the Municipal Code of Des Moines, 1991, adopted by Ordinance No. 11,651, passed April 15, 1991, and amended by Ordinance No. 11,953, passed March 15, 1993, and amended by Ordinance No. 13,136, passed January 3, 1995, and amended by Ordinance No. 13,455, passed April 21, 1997, by repealing Section 15-181, thereof and enacting a new Section 15-181, all relating to Blank Park Zoo fees.

Be It Ordained by the City Council of the City of Des Moines,

Iowa:

Section 1. That the Municipal Code of Des Moines, 1991, adopted by Ordinance No. 11,651, passed April 15, 1991, and amended by Ordinance No. 11,953, passed March 15, 1993, and amended by Ordinance No. 13,136, passed January 3, 1995, and amended by Ordinance No. 13,455, passed April 21, 1997 be and is hereby amended by repealing Section 15-181 thereof and enacting a new Section 15-181, all relating to Blank Park Zoo fees, as follows:
