

ORDINANCE NO. 13,640

AN ORDINANCE to amend the Municipal Code of Des Moines, 1991, adopted by Ordinance No. 11,651, passed April 15, 1991, and amended by Ordinance No. 13,339, passed May 28, 1996 and amended by Ordinance No. 13,407, passed January 6, 1997, by repealing Sections 27-1555, 27-2505 and 27-2632, thereof and enacting new Sections 27-1555, 27-2505 and 27-2632, all relating to traffic regulation changes.

Be It Ordained by the City Council of the City of Des Moines,

Iowa:

Section 1. That the Municipal Code of Des Moines, 1991, adopted by Ordinance No. 11,651, passed April 15, 1991, and amended by Ordinance No. 13,339, passed May 28, 1996 and amended by Ordinance No. 13,407, passed January 6, 1997, by repealing Sections 27-1555, 27-2505 and 27-2632, thereof and enacting new Sections 27-1555, 27-2505 and 27-2632, all relating to traffic regulation changes,as follows:

**27-1555. FIRST STREET--VINE STREET TO AURORA AVENUE.**

First Street, on the east side, from Vine Street to a point 50 feet north thereof, no parking any time.

First Street, on the west side, from Court Avenue to a point 45 feet south thereof, commercial loading zone.

First Street, on the east side, from Court Avenue to a point 45 feet north thereof, no parking any time.

First Street, on the east side, from Walnut Street to a point 55 feet south thereof, no parking any time.

First Street, on the west side, from Walnut Street to a point 40 feet south thereof, no parking any time.

First Street, on the west side, from a point 100 feet south of New York Avenue to Corning Avenue, no parking any time.

First Street, on the west side, from a point 230 feet south of New York Avenue to a point 80 feet south thereof, no parking any time.

First Street, on the east side, from Sheridan Avenue to a point 75 feet north thereof, no parking any time.

First Street, on the east side, from a point 80 feet south of New York Avenue to a point 75 feet north of Sheridan Avenue, commercial loading zone.

First Street, on the east side, from a point 80 feet south of New York Avenue to Euclid Avenue, no parking any time.

First Street, on the west side, from Euclid Avenue to a point 50 feet south thereof, no parking any time.

First Street, on the east side, from Douglas Avenue to Aurora Avenue, no parking any time.

**27-2505. EAST OLINDA AVENUE--SOUTH UNION STREET TO EAST INDIANOLA AVENUE.**

East Olinda Avenue, on the north side, from South Union Street to a point 50 feet east thereof, no parking any time.

East Olinda Avenue, on the north side, from Indianola Avenue to a point 60 feet west thereof, no parking any time.

East Olinda Avenue, on the south side, from South Union Street to East Indianola Avenue, no parking any time.

**27-2632. THOMPSON AVENUE--EAST NINTH STREET TO EAST THIRTY-FIFTH STREET.**

Thompson Avenue, on the south side, from East Ninth Street to East Fourteenth Street, no parking any time.

Thompson Avenue, on the south side, from East Fourteenth Street to a point 50 feet east thereof, no parking any time.

Thompson Avenue, on the north side, from East Fourteenth Street to a point 50 feet east thereof, no parking any time.

Thompson Avenue, on the north side, from East Fourteenth Street to a point 75 feet west thereof, no parking any time.

Thompson Avenue, on the south side, from Stewart Street to De Wolfe Street, no parking any time.

Thompson Avenue, on the south side, from East Twenty-second Street to East Twenty-fifth Street, no parking any time.

Thompson Avenue, on the north side, from a point 50 feet west of East Twenty-third Street to a point 50 feet east of East Twenty-third Street, no parking any time.

Thompson Avenue, on the south side, from East Twenty-seventh Street to East Twenty-eighth Street, no parking any time.

Thompson Avenue, on the north side, from East Thirty-third Street to East Thirty-fourth Street, no parking any time.

Thompson Avenue, on the south side, from East Thirty-fourth Street to East Thirty-fifth Street, no parking any time.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
