

ORDINANCE NO. 13,672

AN ORDINANCE to amend the Municipal Code of Des Moines, 1991, adopted by Ordinance No. 11,651, passed April 15, 1991, and amended by Ordinance No. 11,953, passed March 15, 1993, and amended by Ordinance No. 13,430, passed February 3, 1997, and amended by Ordinance No. 13,569, passed January 19, 1998, by repealing Section 15-174 thereof and enacting a new Section 15-174, relating to soccer field rental fees.

Be It Ordained by the City Council of the City of Des Moines,

Iowa:

Section 1. That the Municipal Code of Des Moines, 1991, adopted by Ordinance No. 11,651, passed April 15, 1991, and amended by Ordinance No. 11,953, passed March 15, 1993, and amended by Ordinance No. 13,430, passed February 3, 1997, and amended by Ordinance No. 13,569, passed January 19, 1998, by repealing Section 15-174 thereof and enacting a new Section 15-174, relating to soccer field rental fees, as follows:
