

ORDINANCE NO. 13,885

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, by repealing Section 126-70.2 thereof and enacting a new Section 126-70.2, regarding qualifications for limousine drivers.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, is hereby amended by repealing Section 126-70.2 thereof and enacting a new Section 126-70.2, regarding qualifications for limousine drivers, as follows:

Sec. 126-70.2. Qualifications for limousine driver's license.

(a) *Requirements.* Each applicant must meet the following requirements before a license may be issued:
