

ORDINANCE NO. 13,894

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, by repealing paragraph (e) of Section 102-1131 thereof, relating to street use permit fees.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, is hereby amended by repealing paragraph (e) of Section 102-1131 thereof, relating to street use permit fees, as follows:

Sec. 102-1131. Fees.

(a) General requirement. An applicant who seeks a street use permit shall pay a nonrefundable application fee of \$250.00 at the time of application and within ten days before the event post a refundable \$500.00 cash bond to the city to guarantee payment of the actual cost of city equipment and services.

(b) Exceptions to general requirement. An applicant who seeks a street use permit in conjunction with any of the following licenses and permits, or with a residential event, or is a recognized neighborhood association shall pay the specified fees for the street use permit or no fee as follows:

(c) If the permitted use
will require more than

minimum use of any city equipment or services, the applicant shall pay the actual costs for use of that equipment and those services in accordance with a schedule of rental and service fees approved by the city council.

(d) As a condition of approval of an application, the applicant shall agree to pay, within 30 days of billing, any additional actual costs, for the use of city equipment and/or services, incurred by the city by the occasion of the event and its participants.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
